Aloha,

As a resident of the Wailua Houselots, I would like to express my opinion regarding the development of Coco Palms. It is our front yard, or "welcome mat" if you will, and it is a dangerous eyesore.

I am sincerely empathetic to and appreciative of the cultural and religious significance of the site. The email I received from Fern Holland/Wailuanui.org on 10/6/2022 requesting I submit testimony to your department says, "This site could become a thriving example of living Hawaiian culture, mālama 'āina, sustainability, education, history and music." The email also says, "We have been developing a path forward to support the cultural and environmental restoration of this important place." Wouldn't that be wonderful? The issue is I have zero confidence this will ever transpire. In another 30 years, I fully expect that if it is not developed, that it will remain as is, a dangerous eyesore; a sad looking "welcome mat" for the Wailua and Kapa'a area, if you will.

It is incomprehensible how anyone expects a developer who has invested over \$20 million for the property and over \$100K for permits to just donate the land to the county or state. Even if they did donate it, does anyone have any idea how much money it would take to bring Fern's vision to fruition? It would be many, many millions of dollars. And if it ever did come to fruition, who would maintain the place? Who would pay for said maintenance? Who would operate it? How would the operations be funded? So many questions, and so little answers or money.

Below are some of the reasons I am open to the development of the property into a hotel. The developer has agreed to or already has complied with the following:

- Will comply with an affordable housing component in the area of the development.
- Will comply with the Planning Department's request to:
 - a. Submit a revised SOW for the project, including any proposed work with potential to affect the historic lagoon, including staging areas, construction of new bridges, dredging, or filling in of areas near the lagoon;
 - b. Provide information regarding any potential federal funding or federal permits that may be required, especially relative to the historic lagoons;
 - c. Conduct an Intensive-Level Survey (ILS) that identifies and assesses all remaining architectural historic properties and their potential eligibility for the Hawaii and National Registers;

- d. Have a Burial Treatment Plan (BTP) that meets HAR §13-300-34(b), and following a determination by the KLBC regarding burial treatment, a Burial Site Component of a Data Recovery Plan (BSCDRP) that meets HAR §13-300-34(b)(3)(B); and
- e. Have a Revised Archaeological Monitoring Plan (AMP) that includes provisions for addressing architectural monitoring concerns and meets HAR § 13-279-4, including ongoing monitoring during construction and 90 days after completion of construction.
- Will work with the Fish and Wildlife service to minimize impacts to Hawaiian waterbirds as well as adverse impacts on the Federally Listed Threatened Species, Newell's Shearwater and other seabirds, all external lighting shall be only of the following types: shielded lights, cut-off luminaries, or indirect lighting. Spotlights aimed upward or spotlighting of structures, landscaping, or the ocean shall be prohibited.
- Shall seek to hire Kauai contractors as long as they are qualified and reasonably competitive with other contractors and shall seek to employ residents of Kauai in both temporary construction and permanent jobs.
- Will implement sustainable building techniques and operational methods such as LEED Building Standards.
- Has contributed \$10,000 to the County of Kauai Transportation Agency to assist with the construction of a new bus stop along Kuhio Highway in the Wailua area.
- Will work with the State Department of Transportation to provided landscaping along the strip of land fronting Kuhio Highway and properly maintain this landscaping in perpetuity.
- Will provide 20 public parking spaces at the north end of the project site for use by beachgoers and those using public transportation.
- Will provide 20 public parking spaces at the south end of the project site for use by beachgoers and those using public transportation.
- Will design, construct, and maintain in perpetuity, a comfort station consisting of restrooms and showers for beachgoers.
- All parking for guests, customers, and employees will be accommodated on site and no parking will be Kuamoo, Haleilio or Apana roads shall be allowed.
- To mitigate traffic impacts created by the development, the developer has/will:
 - o Paid \$50,000 to the County of Kauai to assist in the Planning Department's historic Preservation mission to perpetuate the cultural and historic significance of the Wailua region to include the creation of educational programs and signage.
 - o Paid \$50,000 to the County of Kauai to assist with the County's placemaking efforts including moku and ahupuaa signage of the Wailua area.
 - o Provide a shuttle for a minimum of 18 months to/from the Lihue Airport for hotel patrons.
 - o Provide a circulator shuttle, for a minimum of 18 months, to move patrons from the hotel to Lydgate and Wailua Beach Park, the Seashell Restaurant, the Coconut Market place, and ither destinations within the main Kapa'a transit corridor as determined by the County of Kauai Executive on Transportation.
 - o Provide a bike share program for patrons.

- Work with the State DOT and Department of Public Works to resolve pedestrian crossing, sidewalk, and vehicular traffic demands and bear associated costs proportional to the impact that arises from the development.
- O Work with the DNLR to obtain permission to use the lands held for least to all ow mauka access for either vehicular and/or bike/pedestrian traffic for residents between Kuamoo and Haleilio Roads..
- o Paid \$93,750 towards the cost of a dedicated right turn on Haleilio road from Apana Road to Kuhio Highway.
- o Paid \$93,750 towards the design and construction of a widened Apana road from the project entry on Apana Road to Haleilio Road.
- o Will encourage employees to use the County Transportation Agency transit services having promotional events encouraging usage of said transit services to include selling bus passes, signage, etc.

Again, while I appreciate the cultural significance of the site, I do not believe that this has to be a lose-lose. I believe the county and developer can come to an agreement that would satisfy both sides. In his 10/09/2022 VOICES letter to the Garden Island News, Kauai County Council Vice Chair Mason Chock says, "We have to lead with culture, not money, for our community to ultimately thrive. We should expect more without having to compromise who we are or the places we cherish. We deserve growth that honors our past and protects our future."

I have deep respect for Vice Chair Chock, nonetheless, I disagree with some of his points. The homeless problem on Kauai will not be fixed with culture, it's going to take money. It's going to take more affordable housing. It's going to take first-time homebuyer programs that make homeownership a reality. And life is nothing more than compromise, give and take, back and forth.

This project CAN be a win-win. I absolutely agree that this project can be one that honors our past and protects our future. I do not support the blocking of the development. To do nothing for another 20-25 years is not the way.



The Wailua Bay View AOAO Board of Directors would like to provide a strong recommendation for you to grant the necessary building permits for the Coco Palms parcel so that Stillwater Equity Partners can begin rebuilding the project. For the last 15 years, but especially since the start of the pandemic, many, many homeless (up to 20 or more) are living in the old Seashell Restaurant (Part of the Coco Palms Parcel). They lit open fires to cook food every night INSIDE the Seashell Restaurant putting our \$10M building and 4 feet away propane tank in serious danger. We are grateful that the State and County have engaged in the last month to significantly reduce the problem however we all know that while the Coco Palms skeleton buildings sit fallow, they will continue to attract homeless people seeking relief from the elements. We understand there is a very vocal minority who do not want the Coco Palms parcel to be redeveloped, however please consider that every year that goes by where the building skeletons sit idle, the neighbors around those buildings will suffer. We are TIRED of this, please heed:

Developers continue to move forward with their intention to develop a hotel across from Wailua Beach, on the former Coco Palms property. A Petition For Declaratory Order was filed by a coalition of environmental organizations including Sierra Club Kaua'i Group, Surfrider Foundation Kaua'i Chapter, and Hawai'i Alliance for Progressive Action (HAPA) in August 2022. The order essentially states that according to law and court precedent, the permits issued to Coco Palms Hui in 2015 have lapsed due to their failure to make "substantial progress".

It's obvious to anyone driving by the property today in January of 2023 there has definitely not been "substantial progress" over the past 8 years – let alone the past 30 years. Installing a construction dust screen just days before the developers are supposed to prove "substantial progress", as is required by the county for the permits to remain valid, does not fulfill the intent of the law either.

Further, the permits granted in 2015 allowing the developer to ignore important existing county building rules and regulations were amended in 2018 after the "Iniki Ordinance" had already expired. This is special legislation on top of special legislation. It is time for this historical site to be given the protection, restoration and respect it deserves for the benefit of future generations and Kaua'i. Rather than a private hotel development, we envision a public place of cultural enrichment, historic preservation, land conservation and spiritual nourishment; an educational and interpretive gathering place; a center of Hawaiian cultural stewardship; a place of food production: and a core place for learning in Hawai'i.

Developers have had 8 years and no substantial progress has occurred on the site. We understand that even 2 years should invalidate these permits and require new applications. Please ask the commission to acknowledge this truth, follow the law, and make a good decision for the betterment of Kaua'i.

In addition to the hugely significant history and sites located on the property, there are traffic issues, climate change, mismanaged tourism concerns and the desire to restore ancient food production infrastructures, like those located in Wailuanuiahoʻāno, to better sustain our people.

PLEASE!!! Honesty and Integrity are needed here to correct this hewa!

For sooo many reasons. I wince, as it hurts my psyche every time I pass this area. In truth, It is the same for most people of Kaua'i. And they feel their own pain and bear witness to the wishes of ancestors who spirit and bones inhabit this as home.

A generation has passed since the hurricane; if was meant to be, it surely could have happned before now. We have had a long time to reflect and consider.... was it ever really pone to replace a sacred wahi pana with hollywood version of our culture? Which King belongs there? Which culture?

A lot was erased before we had laws protecting sacred sites; before we felt pride enough in our own heritage, not to replace it with a synthetic version, selling out to foreign interpretation and ownership which hired locals to play caricature roles of their own local history. This place is sacred from the time of Moikeha and early Polynesian settlement; it is literally written in the stars, not to mention the deep oral and written literatue of place.

It suffers from too much-ness—greedy developers who pay lip service, rather than respect for the site. There has been NO SUBSTANTIAL PROGRESS in the last 30 or even 8 yrs. Permits needed have changed with population and other safety restrictions.

We don't need another hotel, (especially here), but at all in the Kapa'a Wailua area! The roads and infrastructure, and current permits required simply don't condone. The site can't bear the burden of current residents and over 30,000 visitors/day. Do the right thing, follow the law as it is and end the circus and never-ending story. No more extensions and special consideration to Big \$\$\$\$\$ outside investors.

It is time for this historical site to be given the protection, restoration and respect it deserves for the benefit of future generations and Kaua'i. Rather than a private hotel development, we envision a public place of cultural enrichment, historic preservation, land conservation and spiritual nourishment; an educational and interpretive gathering place; a center of Hawaiian cultural stewardship; a place of food production: and a core place for learning in Hawai'i.

Wailuanuiaho`āno is considered one of the most significant political and religious places on Kaua`i, and throughout Hawai'i. With incredible cultural significance and history this site has so much more to offer than accommodation for transient guests. This site could become a thriving example of living Hawaiian culture, mālama 'āina, sustainability, education, history and music.

Using the cost share approach, it is a very small price to pay for the people of Hawaii, through our tax dollars, to establish a Hawaiian park on the land of Coco Palms. A land steeped in Hawaiian culture and lore, it can once again live and thrive as a place for all. As a park it will do this.

However, aside from being a park, there are so many practical issues that make Coco Palms Park a huge advantage for the state and county governments. Infrastructure alone is reason enough.

TRAFFIC SUPPORT: Coco Palms is located in the middle of busiest traffic corridor on the island of Kauai. With the right planning the front of Coco Palms can be better utilized for resolving traffic issues.

WASTE WATER SUPPORT: The main sewage waste water lines run in front of Coco Palms and a pumping station is located on the property to direct sewage to the nearby sewage treatment plant.

SPECIAL FLOOD HAZARD AREA: Coco Palms is located in a special flood hazard area with a base flood elevation of approximately eighteen (18) feet. By limiting construction in this area it will reduce the threat of destruction to neighboring properties during a storm event.

IMMENENT DOMAIN: With the overwhelming growth that has already taken place in the immediate area it has rendered the current infrastructure: such as roads, bridges, electrical distribution lines, water mains, etc, incapable of functioning normally. When this property is owned by a government entity, the infrastructure costs will be greatly reduced since there will be no need to acquire the property through forced legal proceedings of imminent domain.

It is the right time for our legislatures to see the value of this land and the urgency for which it is needed.

My name is Puali'ili'imaikalani Rossi-Fukino and I was raised in the moku of Puna, in the ahupua'a of Wailua. I am able to trace my mo'okū'auhau (genealogy) to Wailua through my great-great-grandmother, Kepalina, who was born and raised in this special place.

I am writing this to humbly request that you rule that the permits for the proposed hotel are lapsed and no longer valid. Since 2015, we have seen no substantial progress in development. If anything, the site has gone to further disarray and looks even worse than ever before. The developers were granted permission to ignore any and all significant county building rules and regulations by amending the 'Iniki Ordnance, which had already expired.

It is crucial that we stop any future development of the Coco Palms site. This site is no longer suitable for a hotel, nor is it suitable for any further commercial development. Testimony: SUPPORT for Petition for Declaratory Order

Aloha Commissioners,

The testimony below represents my thoughts and viewpoint presented as an individual only and does not represent any organization that I may be affiliated with.

I strongly urge the Commission to SUPPORT the Petition for Declaratory Order and acknowledge what seems so obvious to most residents in the community - that since receiving their permits in 2015, the owners of the Coco Palms property have not made "substantial progress".

It is a given that the attorneys for the owners will vehemently object and no doubt threaten legal action against the County should the Commission agree the law requires "substantial progress" that has not occurred, thus the permits have lapsed.

The decision and vote before the Commission must be driven by an honest answer to the question: Has "substantial progress" been made? The fear of legal action by high priced attorneys whose job is to threaten, cajole, and obfuscate the facts - should not be the driving factor.

Viewing the condition of the property today in the 8th year since permits were granted, it seems that development has barely even started and the progress to date is a very long way from being "substantial".

According to law and court precedent, the permits issued in 2015 have lapsed due to the failure to make "substantial progress".

I encourage the Commission to focus their attention and their vote, entirely on the law and the question of "substantial progress".

The permits granted under the "Iniki Ordinance" in 2015 allowed the owners/developers to ignore important county building rules and regulations. These permits were then amended in 2018 after the "Iniki Ordinance" had already expired.

The extension of the "Iniki Ordinance" to benefit only this development is a legally flawed foundation of "special legislation" that violates the State Constitution.

In addition, the "Iniki Ordinance" does not allow the County to exempt projects from State law HRS 343 pertaining to environmental impact statements.

The proximity to the coastline, the use of State lands, and the fact that a portion of the property is registered as a historical place - are all factors that "trigger" HRS343 and an environmental review.

I Ola Wailuanui has filed a lawsuit against the BLNR and the developer asking that they in fact require an environmental review of the impact that will occur due to the construction and development of this property. The Commission is encouraged to also require such a review and/or await the determination by the courts prior to allowing further development on the property to occur.

Year after year different owners have stood next to one different developer after another and made promise after promise.

In August of 2022, Parker Enloe, the owners representative at the time assured the Planning Commission they would hold public meetings to hear public concerns, and respond appropriately.

To my knowledge no such public meetings have ever been held.

Shortly after the August Planning Commission meeting, members of the public discovered a Mr. Parker Enloe who had previously pled guilty and been convicted of fraud. When confronted with the information, the Parker Enloe who testified before the Kauai Planning Commission denied that he was the same Mr. Enloe who received the conviction. There must it seems, be another Parker Enloe who resides in the same town, works in the same industry, and has the same friends and associates who wrote the judge letters on his behalf.

Shortly thereafter, it was announced by still yet another representative of the Coco Palms that Parker Enloe would no longer be representing the owner.

The Commission is encouraged to ask this question directly to the present owner's representative. Was their prior representative convicted of fraud?

At a more recent Planning Commission meeting, the owner's representative suggested they were willing to entertain offers from community groups to purchase the property.

It was quickly discovered at a subsequent Zoom meeting his offer was disingenuous at best. The current owner of the property it seems, has already accepted an offer to purchase the property from other investors intent on hotel development.

The present owners cannot sell the property to a third party or community group without violating their contract to the existing buyer who has the property in escrow. In addition, the existing buyer is claiming a more than doubling of real estate value even before they close escrow on the property.

The County is dealing with and accepting promises of future permit fulfillment and development timelines from the present owner (whose prior representative may or may not have been convicted of fraud) while the prospective new owners are waiting in the wings - hoping to cash in.

To further muddy the waters, there are two questions that in addition to consulting with the County Attorney, the Planning Commission should put directly and promptly before the Kauai Ethics Commission.

It is the job and duty of the Ethics Commission to review and rule on these matters and is the only way to put this matter to rest.

While it's sometime difficult and awkward to raise such questions they do in fact need to be raised.

To be clear the questions are not about personal integrity but rather about inherent bias and public perception.

I strongly encourage the Planning Commission to request a formal review and opinion from the Ethics Commission on the below two issues. This matter should not require a complaint to be filed by a member of the public but rather should be a request coming from the Planning Commission itself.

The new Chair of the Kaua'i Planning Commission is also the official Kaua'i Representative for the Hawai'i Carpenters Union. The union and its members will clearly receive a direct financial benefit should the Coco Palms Development move forward.

In addition, the current Vice Chair of the Planning Commission, prior to being appointed to the Planning Commission, had a real estate listing agreement to sell Coco Palms Resort condominium units then being proposed by a previous unsuccessful Coco Palms developer.

It's unclear whether that developer retains a financial interest in the property, and it's also unclear whether this matter has been previously disclosed.

There are many moving parts, but the fundamental question is one of law.

Has there been "substantial progress"? Most residents I believe would say without hesitation, there has not been anything close to that.

Though the weeds and under-brush have recently been cleared, and what looks like a dust screen is being erected pulling the weeds, cutting the grass, and putting up a fence - just days before this hearing does not constitute "substantial progress".

I encourage the Commission to support the Petition for Declaratory Order and to immediately seek a ruling by the Kauai Ethics Commission prior to any formal vote.

Mythology and Mo'olelo

There are few legends or chants associated with Maka'huena Point, and very little for Weliweli ahupua'a. One story concerns the gourd of La'amaomao, in which the winds of Hawaii were stored. This gourd belonged to Paka'a, a servant and advisor to Keawenuiaui the ruling chief of Hawai'i. La'amaomao, Paka'a's mother, has the ability to control the winds (Fornander 1918: 72). Paka'a's son, Kuapaka'a, calls all the winds to all the islands to discredit the advisors who replaced Paka'a as advisor to the king. During Kuapaka'as chant he names the wind that blows through Weliweli as Kuiamanini (Fornander 1918: 96)

One legend recites the search by *Pele* for a home, but is continually driven off by *Wakea*, the ancestor of the people. *Pele* has been searching throughout the islands, and now has landed on *Kaua'i* (Wichman 2001):

Pele's canoe with red sails
Reached Kaua'i just at dawn.
The sound of digging on the cliffs
Woke Wakea from his sleep.
Wakea asked:
Who is digging there at Ke'e?
I, Pele, came the answer.
I am digging a pit to find fire.
A fire pit on Kaua'i, a home for Pele?
Not so, said Wakea
Each time you dig a hole
The waters of Ka-wa-kiki
Will drown your fire.
Kaua'i is no place for you
Move on!

A story relates the involvement with the warrior Lima-loa with the demi-god Kamapua'a in the last battle in the long running war between the districts of Puna and Kona. In the tale, the war between Kona and Puna has been ongoing for three generations as the result of the refusal of marriage by the lovely grand-daughter of Mo'ikeha, the heir to Puna, to Keli'ikoa, prince of Kona. Kamapua'a, in the guise of a man, boasts at the ease with which Kukona's warriors will defeat Mo'ikeha. Kukona, the chief of Kona, has fought on the side of Puna with his warrior Lima-loa, and does not believe it will be so easy. Kamapua'a takes to the battlefield with Lima-loa and Kukona and defeast all who challenge him. Kamapua'a is finally challenged by Makali'i, chief of Kona, and chants an insult:

"The sea is destroying the sands of Kahalahaa, The sea of Hanalei is roaring The sea of Ha`ena is shallow While the sea of Ka-lalau breaks over the land. The spray of the sea flies up,

And my wind and cloud forms appears,
O Makali`i-nui-ku-a-ka-wai-ea,
Small clouds, large clouds,
Tall clouds, and short clouds
And the large cloud standing close to heaven,
That heaven is furious because of you
O Makali`i-nui-ku-a-ka-wai-ea
Your land is not mine,
The whole of Kaua`i has become mine."

Makali'i realizes that this is Kamapua'a, and chants many chants in hopes that Kamapua'a will spare his life. Kamapua'a does spare his life, commanding him give up his kingdom to Kukona and live apart from everyone in the mountain of Ha'upu. Satisfied at ending the wars, Kamapua'a sails to Tahiti (Wichman 2001).

The name Kane'aukai is associated with the boundary between the ahupua'a of Weliweli and Pa'a. A deity of fisherman, he taught those who wished to fish at the point the proper chants to attract fish. Fish caught off the Maka'huena Point by local fisherman today include: awa (milkfish), 'ō'io (bonefish) he'e (octopus), ula (spiny lobster) akule (big-eye scad), and moi (thread fish). The cover photo shows one of the moi fishing locations. They also gathered hā'ue'uke' (sea urchin) and 'opihi (limpet) from the rocks. Salt pans were constructed to collect salt in the sections of the point that contain shallow soil (Kalihiwa et al. 2011). No salt pans were located during the archaeological inventors by Haup et al. (2011)

Paleopathological observations in the remains indicate that the dental health was generally good, with a low frequency of caries and abscessing. There is slight osteoarthritis of the appendicular and vertebral skeleton.






Figure 2: 1921 Aerial Photograph of Köloa Note Maka'huena Point at bottom right.
