A BILL FOR AN ORDINANCE AMENDING CHAPTER 23, ARTICLE 4, KAUA'I COUNTY CODE 1987, AS AMENDED, RELATING TO COUNTY BUSINESS LICENSES

This Bill proposes to amend Chapter 23, Article 4, Kaua'i County Code 1987, as amended, by amending Section 23-4.1 (County Business Licenses) to clarify that peddlers and concessionaires do not require a County license.

A BILL FOR AN ORDINANCE AMENDING CHAPTER 23, ARTICLE 4, KAUA'I COUNTY CODE 1987, AS AMENDED, RELATING TO COUNTY BUSINESS LICENSES

BE IT ORDAINED BY THE COUNCIL OF THE COUNTY OF KAUA'I, STATE OF HAWAI'I:

SECTION 1. Purpose. The purpose of this Ordinance is to amend Chapter 23, Article 4, Kaua'i County Code 1987, as amended, relating to County Business Licenses, by clarifying that peddlers and concessionaires do not require a County license.

SECTION 2. Chapter 23, Article 4, Section 23-4.1, Kaua'i County Code 1987, as amended, is hereby amended as follows:

"Sec. 23-4.1 County Business Licenses.

The Director of Finance shall issue County licenses to businesses as required by Chapter 445, Hawai'i Revised Statutes, [as amended,] except as <u>otherwise</u> provided [in Section 23-4.2 of this Article] <u>by Kaua'i County Code 1987, as amended,</u> <u>including Chapter 23, Article 3 (Peddlers and Concessionaires) and Section 23-4.2</u> (Elimination of Business Licenses)."

SECTION 3. If any provision of this Ordinance or the application thereof to any person or circumstance is held invalid, the invalidity does not affect the other provisions or applications of this Ordinance that can be given effect without the invalid provision or application, and to this end the provisions of this Ordinance are severable.

SECTION 4. Ordinance material to be repealed is bracketed. New Ordinance material is underscored. When revising, compiling, or printing this Ordinance for inclusion in the Kaua'i County Code 1987, as amended, the brackets, bracketed material, and underscoring shall not be included.

SECTION 5. This Ordinance shall take effect upon its approval.
