MISSION STATEMENT

To preserve and protect life, property and the environment of Kauai County from all hazards and emergencies.

DEPARTMENT GOALS

The men and women of the Kauai Fire Department are dedicated and highly motivated to make our community a safe place to live. Our employees have effectively carried out their duties in achieving the department's goals of preventing, suppressing and extinguishing all types of fires; responding to and mitigating any and all types of emergencies (medical, HAZMAT, search and rescue, disasters) in a highly trained, professional and safe manner; administering first aid and CPR to the basic life support level (EMT) and to make Kauai a safer place by supporting and promoting training for the community in CPR, first aid, management of the Kaua'i County CERT (Community Emergency Response Team). Participating in the State and County's Civil Support Team (CST) disaster response training, which includes numerous agencies and resources; providing highly trained personnel as part of Emergency Management Agency's Pacific Rim Urban Search and Rescue (USAR) team; participating in the State and County's localized disaster response network, which includes other agencies and available resources; enforcing the National/Hawaii Fire Code and promote fire prevention through educational programs and community outreach; maintaining our vehicles and equipment for emergency response through a preventive maintenance program; and providing safe, guarded beaches through an effective and dynamic ocean safety program.

PROGRAM DESCIPTION

To accomplish this objective, the department maintains a modern communications and record management system, conducts routine inspections, enforces and governs fire codes and regulations, conducts fire investigations to ascertain its origin and cause, promotes public awareness by providing on-going, up-to-date public education, advocates a structured and uniform fire training program which includes HAZMAT, CBRNE (chemical, biological, radiological, nuclear and explosive) and mountain and ocean search and rescue training, and promotes highly trained fire suppression and hazmat/rescue teams.

The fire department consists of a fire chief, a deputy fire chief, a fire commission, and the necessary staff.

The Fire Chief commands and directs a department of 213 employees--146 uniformed fire personnel, 58 uniformed ocean safety personnel and 9 civilians assigned to five major service bureaus, eight fire stations, ten lifeguard towers located throughout the island, and new this year 3

Roving Jet Ski Patrols one in each of the three districts.

The fire commission appoints the Fire Chief and assists with construction of the budget.

The five major service bureaus are Administration, Operations, Training & Research, Prevention, and Ocean Safety. The eight fire stations house 8 engine companies, a Rescue Unit and a HAZMAT Team, 8 (eight) engine pumpers, 8 (eight) mini-pumpers, 1 (one) HAZMAT response vehicle, 1 (one) Heavy Rescue, 1 (one) 26' Radon Rescue Boat, 1 (one) 19' Zodiac Rescue Boat, 1 (one) 19' Whaler Rescue Boat, and 6 (six) Rescue water craft.

HIGHLIGHTS

Accomplishments for the year:

The Department started its 27th Recruit Class on May 1, 2017.

Fire Operations Bureau installed smoke alarms in over 100 homes as part of a grant-funded community-wide effort and continues to provide more homes as they partnered with the American Medical Response, County of Kauai Office of Elderly Affairs, the State Department of Health Fall Prevention, and the Friends of the Kauai Fire Department

The Prevention Fire Safety Trailer has been a resounding success in the community with over 5,000 public encounters annually. We trained 519 community members on fire extinguishers, and 720 total encounters to our Fire Safety presentation. The eighth annual brushfire mitigation meeting was held at the beginning of the summer season for the major landowners of Kaua'i.

This year the Fire Department responded to over 6,330 calls for assistance a slight increase over the previous year staying round an annual increase of 24%. We had 280 Fire calls of which we investigated 11 fires this year with a total value loss estimate of \$1,700,000.00 in damage and property. The busiest fire station ran 900 plus calls while each of the next three busiest stations ran over 800 calls each. They responded to 14% of the calls each. We responded to 4,600 medical calls an increase of 4% medical calls. Total calls are up 34% since 2002.

The Water Safety Officers have done a tremendous job in securing the safety of our public and visitor alike. We have had a not-so-good year with 16 drownings and increasing beach visitor counts. However, we were able to record over 478 rescues and assists, with 168 by Jet ski (prior to the Roving Patrol) and another 44 using rescue water craft in the newly formed Roving Patrol. This year we estimated over 2,304,134 sunbathers, surfers, and swimmers enjoyed our beaches, this is double of the last years tally. The Ocean Safety Bureau recorded over 231,438 beach contacts where we informed or discussed the safety of the beaches with beachgoers, everyone a potential save. The WSO's under the Fire Department are very professional, highly trained with proper certifications, and more "customer service" oriented. The Kaua'i Junior Life Guard program was finally defeated in the State Champions for the first time in 12 years. The Keiki Guard program continues to be a success with more students than the

current program can handle and turning away keiki. The cooperation between private organizations and government are what makes our education programs so successful. The WAVE (water awareness visitor education) program in cooperation with HTA (Hawaii Tourism Authority) places KORC (Kauai Ocean Resource Council) Trainer Pat Durkin in our hotels training concierges about Kauai's beaches and how to advise tourist about our beaches is working great. The Rescue Tube Initiative sponsored by the Rotary Club of Hanalei Bay has placed over 200 tubes around the island with a lifesaving credit of over 120 lives. We were successful in getting a couple of questions in the KEDB exit survey and preliminary results show where we need to target our public education market.

ACTIVITIES

The KFD Outstanding Firefighter of the Year was Mike Scovel and Ocean Safety Officer of the Year Dave Duncan were both honored at the annual employee recognition banquet held at the Kauai War Memorial Convention Hall.

Fire Prevention Week Activities took place the week of October 9. It is a commemoration of the Great Chicago Fire of 1871. The 2016 National Fire Protection Association's Fire Prevention Week theme was "Don't Wait-Check the Date! Replace Smoke Alarms Every 10 Years".

Various members of the department attended several conferences, National Fire Protection Association Annual Meeting and Conference, International Association of Fire Chiefs Annual Conference and Training and Trade Show, Quarterly Labor/Management meetings, Quarterly State Fire Council Meeting, Monthly Water Safety Task Force.

Kaua'i Community Emergency Response Team (CERT) became an integral part of our department this year and we are working with Kauai Emergency Management Agency (KEMA) and Kauai Police Department (KPD) to grow the program island wide. We added 67 graduates to our rolls and another 65 participated in additional training classes.

PROGRAM MEASURES – ACCOMPLISHMENTS/EVALUATION

Fire Personnel conducted station visitation tours for schoolchildren and other interested groups. They provided fire safety awareness speakers and training to the schools and community including home owners, students at Career Day activities, hotel and business organizations and senior citizen groups in the Department's continuing efforts to support and provide program assistance to the public toward its continued awareness of safety and the need for community input as they grow, so do the needs for safety awareness.

During the months of September through December fire companies continue to assist the Department of Land and Natural Resources in its crusade to assist with the aiding of fallen Newell Shearwaters.

Free blood pressure screening continues to be available at all eight Fire Stations; these services are available every day between the hours of 9:00 am and 8 p.m.

8 Firefighters and 2 OSO2's completed the National Registry for Emergency Medical Technician (EMT) program and certification and now the total in the department to 47.

OPERATIONS BUREAU

FIRE SUPPRESSION AND EMERGENCY CALLS

The fire line suppression is comprised of 3 Battalion Chiefs, 135 Fire line personnel, 21 Fire Suppression Captains, 3 Hazmat Captains, 3 Rescue Captains, 27 Fire Apparatus Operators, 9 Fire Rescue Specialists, 9 Hazardous Materials Technicians, and 63 Fire Fighters. They respond to fire and hazmat/rescue incidents and assist in all 911 emergency medical calls.

Fire fighters work 24 hour shifts for an average of 56 hours per week. They are assigned to 3 platoons, each consisting of 45 fire fighters. Each platoon staffs 8 fire stations with crews consisting of a Fire Apparatus Operator and Fire Fighters and /or Fire Fighter Trainees under the command of a Fire Captain, with the exception of the Līhu'e Fire Station which has a Suppression Captain and Rescue Captain, two Fire Apparatus Operators and three Fire Rescue Specialists. The Līhu'e Fire Station is the designated home base for the Rescue team.

Fire Fighters are stationed at the Hanalei (E-1), Kapa'a (E-2), Līhu'e (E-3), Kōloa (E-4), Kalāheo (E-5), Hanapēpē (E-6), Waimea (E-7), and Kaiākea (E-8) Fire Stations. Staffing for all of our fire stations are at five with the exception of Līhu'e which is a nine person station.

TRAINING AND RESEARCH BUREAU

PURPOSE

The responsibility of the Fire Department Training and Research Bureau is to train firefighters and support services personnel in a variety of disciplines. Training classes include Incident Command, Fire Ground Operations utilizing our Burn Trailer, Emergency Medical Services such as NREMT certification and refresher training, 1st Responder, and American Heart Association BLS CPR (High Performance CPR), HAZMAT Operations /Technician, CBRNE (chemical, biological, radiological, nuclear, explosive), Apparatus Driver Training, Vehicle Extrication, Ropes and Rescue Operations utilizing low and high angle, helicopter techniques (ARS), Ocean Rescue under USLA (ARRT) guidelines and Swift Water Rescue Training. It is also the responsibility of the Training Bureau to structure the training of new recruits and facilitate training courses for the Prevention, Administrative and Fiscal Bureaus.

The goal of the Training Bureau is to provide proactive response teams with professional skills and knowledge who can work in a safe and efficient manner for the County of Kauai. The Training Bureau is also responsible for the research and evaluation of new equipment for cost effectiveness, compatibility, ease of use, and safety.

The Training Officer acts as the Safety Officer on major operations under the Incident Command System.

DUTIES

The Training Bureau is staffed by three Training Officers: A Captain and two Fire Fighter 3's one being responsible for Emergency Medical Services training who all report to the First Platoon (Red) Battalion Chief for the overall functions and operations of the Training Bureau. The Training Officers are responsible for planning, organizing, implementing, monitoring, and the record keeping of all Training Programs. They research, test, and recommend changes for new and improved fire suppression and Emergency Medical Services technology, safer and more efficient operations and procedures for all disciplines of the fire service.

GOALS AND OBJECTIVES

To develop and maintain proficient, professional and structured training programs that will enhance service to the community and safety for department personnel.

- 1. Enhance safety programs. Train firefighters to think and practice safety at all times on the job.
- 2. Standardize drills to give personnel structured training throughout the department.
- 3. Conduct on duty training regiments on Fire Ground Operations, Extrication and Rope / Rescue Operations, and High Performance CPR to further streamline training costs.
- 4. Developing curriculum / certifications for promotional positions.
- 5. Provide IFSAC Certification through HFD Certification Bureau.
- 6. Continue to utilize FEMA/NFA reimbursed classes to supplement department training.
- 7. Review and update department training manuals.
- 8. Adhere to national standards of firefighter and incident command training.
- 9. Utilize computer programs to maintain and digitize complete and accurate drill records for all personnel.
- 10. Train personnel to the highest medical standards possible: Emergency Medical Responder (First Responder) to NREMT transitioning to Hawaii State EMT B and to AEMT.
- 11. To develop more in- house trainers.

FIRE PREVENTION BUREAU

PURPOSE & INTENT

The Fire Prevention Bureau is tasked with the reduction and prevention of fires and life-safety hazards that lead to personal injury and property damage. Raising public awareness through fire safety education that prevents hazardous conditions from occurring, and heightening the public's awareness of fire prevention is the primary focus of the Prevention Bureau. The Prevention Bureau is also challenged with the timely inspection of schools, hospitals, care homes and other commercial occupancies to minimize hazardous fire conditions; the review and approval of commercial building construction plans to ensure compliance with the County Fire Code and required fire protection features and systems; to review, update, and enforce the County Fire Code; to investigate and determine the origin and cause of fires for statistical data and seek the prosecution of person(s) who cause incendiary fires; and to maintain inspection and investigation records for the assessment of Fire Prevention Bureau objectives in creating a fire-safe environment for the County of Kaua'i.

DUTIES

- 1. To promote fire prevention and life safety awareness in the community.
- 2. To reduce and minimize fire hazard conditions.
- 3. To investigate the origin and cause of fires.
- 4. To enforce the Kaua'i County Fire Code.

ACTIVITIES

The focus of the Bureau is to provide fire safety and fire prevention education to the schools and the community. In an effort to promote "Fire Safety", the Fire Prevention Bureau participates in various business and community activities. These activities include, but are not limited to: Fire Prevention Week, job fairs, career fairs, fire extinguisher training, fire safety education workshops and fire safety displays.

The Bureau has implemented an "in today – out today" priority rule with the reviews and approvals of the majority of building permits. Along with the review of building plans comes the education of contractors, architects and engineers on the current codes and trends. This lends itself to ongoing communications with different businesses and members of the community for clarification and formal interpretations on the Fire Code.

The Statewide School Fire Inspection Program with the cooperation of the State Fire Council (the four County Fire Chiefs), the Department of Education, and the Department of Accounting and General Services continue to provide solutions for Fire Code violations by establishing statewide standards. The goal of the DOE is to meet all Fire and Life Safety concerns, and they are working diligently toward compliance.

Fire Inspections are also conducted on an annual basis at all State run pre-schools on the island. This is upon request by The Department of Human Services. Fire Code compliance is regulated to protect the safety and welfare of our keiki.

"Sparky the Fire Dog" made cameo appearances at various community events i.e., Waimea Town Christmas Parade, Līhu'e Christmas Lights Parade, Kukui Grove Christmas Parade, Kaua'i Farm Bureau Fair, and the Department of Water's "Project Wet" program.

The Prevention Bureau participated in the Contractors Association of Kauai Home Show. People were taught how to correctly use a fire extinguisher with our digital trainer. Advice was also given on smoke alarms and the Fire Code.

The Bureau held demonstrations at the Kauai Regional Science Fair. The theme of the demo was hydraulics. A number of educational toys were on display to demonstrate the power of compressed liquids. The jaws-of-life tools were shown actually cutting apart car doors to convey the principle of hydraulics.

Fire Inspectors Nick Hill and Gavin Kennelly attended the annual local chapter of International Association of Arson Investigators training seminar on Oahu. The annual training covered current topics regarding Lithium battery fire hazards.

Prevention Captain Daryl Date and Fire Lieutenant Kilipaki Vaughan attended the FireShows West Conference and Expo that was held in Reno. This conference provided an array of valuable educational sessions, ranging from fire operations, leadership, and fire prevention.

Prevention Captain Daryl Date attended the EduCode Conference in Nevada. This conference provided education in the utilization of the International Building Code, in which we cross reference quite often in plan review and inspections. An educational session on the hazards of

THC extraction from marijuana was offered. This was invaluable due to Kauai's first medical marijuana farm being established.

Fire Inspector Nick Hill attended an NFPA 13 (Installation of Sprinkler Systems) seminar in Quincy, Massachusetts. This was essential for his temporary assignment role to Fire Lieutenant, whose main responsibility is plan review.

Fire Inspectors Dane Smith and Gavin Kennelly attended NFPA 101 (Life Safety Code) in Denver, Colorado. The Life Safety Code is a standard that identifies requirements for new and existing businesses. Knowledge of it is essential in conducting fire inspections.

Fire Inspectors Nick Hill, Dane Smith and Gavin Kennelly attended NFPA 72 (Fire Alarm Systems) on Oahu. The ins and outs of proper fire alarm installation, maintenance and testing was the focus of this training.

Fire Inspectors Nick Hill, Dane Smith and Gavin Kennelly attended the New Fire Arson Investigator Academy in Las Vegas, Nevada. This seminar covered the basics of conducting a fire investigation.

New Fire Inspectors Sean Kitamura and Blair Yamashita attended a Fundamentals To Fire Investigation course put on by the International Arson Investigators Association in Las Vegas, Nevada. These two inspectors are now educated in conducting a fire investigation, when it occurs.

The ninth annual Brushfire Mitigation meeting was held at the beginning of the summer season for the major landowners of Kaua'i. This is an opportunity to remind the landowners of their responsibilities per the fire code as it relates to wildland urban interface. The CWPP (Community Wildfire Protection Plan) for Kaua'i was discussed. Landowners are informed of federal grants that are available for brushfire mitigation. Contacts are updated, as well as a list of resources that may be available in fire situations. A meteorologist from NOAA also gave a presentation on the weather outlook for the calendar year.

The Prevention Bureau assisted in the training of the latest recruit class of firefighters. The recruits were taught the duties of fire prevention such as: inspections, investigations, and public education. They were brought to a number of different businesses to go through actual fire inspections.

For the very first time, the Bureau acquired a drone for the Fire Department to be utilized for inspections, investigations, and reconnaissance during emergency incidents.

The Fire Safety Trailer again was the hub of the Bureau's education program. The Trailer was brought to all of public elementary schools as well as some private and charter schools. Emphasis was placed on having the first and third grade students experience this handson training device. With the smaller schools, the entire student body was able experience it.

We participated in a number of community functions such as: the Prince Kuhio Day

celebration in Anahola, Home Depot's child project day, Kmart's Child Safety Day.. The Fire Safety Trailer was also present at a few businesses such as: Wilcox Hospital, Kauai Coffee, Sheraton Kauai, and DOW Agroscience,

Fire Prevention Week – October 9-15, 2016

Fire Prevention Week Activities take place on the week of October 9. It is a commemoration of the Great Chicago Fire of 1871. The 2013 National Fire Protection Association's Fire Prevention Week theme was "Don't Wait-Check The Date! Replace Smoke Alarms Every 10 Years".

The Fire Fighter's Safety and Health Guide Program (FFSHG) has been implemented throughout the State for twenty-two years. The Guide features a multi-page booklet with fire prevention messages, fire safety messages and problem solving activities. Students in grades K through 5 draw individual home fire escape plans with the assistance of parents and teachers. Students are also encouraged to practice their fire escape plan with their families to insure that the proper procedures are followed in the event of a fire emergency.

As an incentive for student participation, the FFSH guides contained a coupon book with a number of valuable coupons.

This is the fifth year that we incorporated the fire safety trailer to educate the children on the basic principles of fire safety, such as: have working smoke alarms, create a fire escape plan showing 2 ways out, have a safe meeting place, call 911 from a safe location, and to practice the plan. Not only was education focused on fire safety, but hands-only CPR was also included as a component into the curriculum. This very simple technique has proven to be effective in resuscitating someone in cardiac arrest. Thousands of adults and children will now be educated on this life saving skill.

The Fire Fighter's Safety and Health Guides are distributed in the Fall Semester for Fire Prevention Week. The Fire Safety Trailer goes to the schools in the Spring Semester to help reinforce the fire safety messages.

The Fire Prevention Week message was distributed in The Garden Island newspaper in a number of different languages: English, Japanese, Hawaiian, and Filipino. A spadea in the Sunday paper profiled all of the members of the fire department at their respective work assignments, as well as fire safety tips.





OCEAN SAFETY BUREAU

MISSION STATEMENT

The mission of the Ocean Safety Bureau is to provide a comprehensive ocean safety and lifeguard program for the island of Kaua'i. That includes prevention, response, rescue and public education components.

PROGRAM

The Kauai Fire Department, Ocean Safety Bureau has the responsibility to provide ocean safety awareness, safeguarding beach patrons, responding to emergencies, and providing medical aid. A professional lifeguard service protecting Kauai's residents and visitors. The Ocean Safety Bureau program also includes prevention, risk management, ocean rescues, completing records and reports, training and maintenance of equipment, and public education programs. With support of different community groups, like the Kauai Lifeguard Association, Hawaiian lifeguard Association, The Kauai Visitors Bureau, State Drowning and Spinal Cord Injury Prevention Committee, The Rotary Clubs, the goal of raising ocean awareness is being realized.

Staffing is the most vital component to any life guarding service. There are 50 full-time positions, and 9 part-time positions, in the Ocean Safety Bureau, 4 of the full-time and 1 part-time positions are State funded for Kē'ē Beach. OSB has a three district operation, District #1= North, District #2 = East district, and District #3 = South/West district, with 1 working supervisor, and 1 Captain in each district. A prevention/training OSO IV Captain oversees an OSO III training position, responsible of keeping all mandatory certification training, prevention and education programs, and creating training to the highest effective level. The Ocean Safety Bureau also has an office support technician/clerk assisting with all office duties, with an overall bureau operations supervisor overseeing all operational tasks.

There are a total of ten (10) Lifeguard Towers in full-time operation. North District;

Hanalei (Pavilion), Hanalei (Pine trees), Hā'ena Beach Park, and Kē'ē beach. East District; Anahola, Keālia, and Lydgate beach. South/West District; Po'ipū, Salt Pond, and Kekaha Beach.

Equipment is another important part of the rescue operations. We currently have the three districts with a Roving Patrol Jetski units. With the Fire Departments rescue boats, the Island of Kauai is well covered by ocean going vessels. All-terrain vehicles (ATV) are also used in the OSB's operation Kealia, Ha`ena, Kē'ē, Lydgate, Anahola, and Kekaha Beach, which are utilized in a professional and successful manner. 3 new utility vehicles (Mules) are also stationed at vary locations to assist with patrols and response times.

PROGRAM OBJECTIVES

- To promote ocean safety awareness in the community, and develop a drowning prevention educational program.
- To provide lifeguard services at beach areas around Kauai as determined by risk management, demographic analysis and resource allocation.
- To maintain and develop training programs to assure our personnel are at the highest effective level.
- To develop and implement an effective management structure with an appropriate span of control.
- To increase personnel to a more effective level.
- To reduce response times and increasing the chain of survival by upgrading to the state of the art equipment.
- To integrate smoothly with current emergency response units

ACTIVITIES

Education is a huge part of the Ocean Safety Bureau's program. The Junior Lifeguard program is an ongoing success, targeting 12 to 17 yr. old young men and women. In 2016 the ocean safety bureau produced a few State Champions and placed #2 in the State Championships. Getting second place after a long winning streak of twelve consecutive years. There were over 250 kids who participated in the program. There were 5 different locations, Salt Pond, Poʻipū, Hanalei, and two at Kalapakī. With 5 locations we could cover most of the Island to educate Kauai's youth of ocean safety awareness and keep the next generation active, drug free, and positive. This program was made possible by a number of community groups and agencies, like the Kauai Lifeguard Association, Hawaiian Lifeguard Association, and Fire Department. This program is a great recruiting tool for future lifeguards for the bureau, as we have 6 employees whom graduated for the Jr Lifeguard program.

The OSB assisted and accompanied 26 Jr Lifeguards to the 2016 National Championships at Redondo Beach, California. A few individuals became national champions and one of our female participants got chosen to be on the USA world youth team.

The OSB also has a Keiki Lifeguard program for kids 8 to 11 years of age. The Keiki program included 5 locations, Salt Pond, two at Hanalei and Kalapaki beach with 50 kids per

location, for a total of 250 participants.

OSB is involved with a number of community service events around Kaua'i. OSB was involved in the annual Kauai World Challenge one man canoe race, the Hanalei Bay ocean swim, and Na Pali SUP race. Other community groups like High School career days and different intermediate schools also benefit from Ocean Safety Awareness presentations.

Mandatory training has been ongoing to warrant the highest level of a professional. Training includes Open Ocean Lifesaving training following the guidelines of the United States Lifeguard Association (USLA), annual First Responder recertification, and annual CPR/AED certifications. Other training involves ATV safety rider's course, Emergency Vehicle Driver training and Boating Safety training.

The Roving Mobile Units have developed into mandatory training because of the numerous outstanding rescues, reduction of drowning incidents and the increase of community preventions and awareness. The Rescue Craft Program has definitely enhanced ocean safety services, by reducing response times, extending beach coverage, and lifesaving techniques are setting standards worldwide. Additional rescue craft training was provided by the Ocean Safety staff. Future goals are to work together with the outer Islands and the union to create a rescue craft operator position. A supplemental agreement has been established for operator and crew member compensation.

Effective December 1, 2016, three new roving mobile patrol units have been added to OSB operations, one unit per district. Two personnel, a truck with a jet ski, trailer, and all the proper rescue equipment will be utilized at other beaches around Kaua'i, extending our services and creating less response time various beach locations. Six new part-time positions were added to help staff towers and allow full-time personnel to operate the new roving patrol units.

All trucks are equipped with AED's, O2 units, 1st aid kits, and all proper ocean rescue equipment. All the trucks are available to respond to any ocean related emergencies and will not have to use the tower equipment.

The new prevention/education trailer has been in full operation and has become very valuable to the Ocean Safety Bureau. The trailer has been utilized at various schools, career days, farm fair, and any other organization requesting ocean safety awareness presentations or education. The education trailer has been very useful to the Jr. Lifeguard Program as well. OSB & KLA has combined forces in producing a NEW ocean safety video that is playing regularly at the baggage claim areas of the Lihue airport and a few resorts around the Island.

There were 16 deaths, related to drowning from swimming pools, snorkeling, fresh water, or scuba diving accidents. All 16 drownings occurred at unguarded beaches. With 478 rescues/assist, we had the potential for a much higher count. Also note the rescues do not count the Fire Department rescue, local surfer rescues, or other public assistant rescues.

ACTIVITY SUMMARY

The fiscal year ending June 30, 2017 was a well below average year statistically.


