The Police Commission consists of seven members who are appointed by the Mayor and confirmed by the County Council. The Commission adopts rules as it may consider for the conduct of its business and regulations of matters relating to the goals and aims of the department. (Article XI 11.03.A)

Appointments are for a three year term with a maximum of two terms.

The Police Commission receives, considers and investigates charges brought by the public against the conduct of the department or any of its members. The Commission is also responsible for reviewing the annual budget. (Article XI 11.03.B/C)

Office of the Chief of Police

The Chief of Police is responsible for the preservation of the public peace, protection of the rights of persons and property, prevention of crime, detection and arrest of offenders, and enforcement of all laws of the State and County ordinances and all rules and regulations.

The Chief of Police is responsible to equip, train, maintain and supervise a force of police officers and civilian staff. The Chief is also responsible for the serving of processes and notices both in criminal and civil proceedings.

The Chief of Police plans, organizes staffs, directs and controls the personnel and resources of the department, and administers the department in a manner consistent with the Charter of the County of Kaua'i and the laws of the State of Hawaii.

The Office of the Chief of Police provides overall direction and supervision to all of the sub-units and personnel of the department. It establishes departmental goals and priorities and monitors the progress of bureaus in attaining these goals. It also directs and supervises the information gathering and enforcement efforts of the Criminal Intelligence Unit (CIU) and Office of Professional Standards (OPS) which investigates complaints against police officers.

A. Program Objectives – Office of the Chief of Police:

To enhance and institutionalize the philosophy of Community Policing and the creation of a positive and pro-active partnership between police officers and our citizens; to be responsive to the needs of our community.

To increase positive interactions and programs with and for the youth of our community to reduce the probability of youth crimes.

To develop and promote an internal work environment based on mutual respect, dignity, and trust; to ensure that all employees are treated fairly and equitably.

To provide efficient and aggressive law enforcement so as to prevent criminal behavior, and to apprehend those responsible for criminal acts.

To aggressively pursue and obtain the resources, training, and equipment needed by our employees to maximize their efficiency and effectiveness.

The Kaua'i Police Department supports the belief that there is a direct correlation between an increase in drug arrests and seizures, and subsequent decrease in the number of overall

crimes. To this extent we remain committed to ensuring that all possible efforts will be taken to reduce drug related elements within the Community.

The amount of new hires, especially police officers, continues to be a reflection of the positive strides being made in this area. However, keeping pace with retirement and other attrition factors have been and will remain a challenge in fiscal year 2018.

B. Program Highlights - Office of the Chief of Police

One of the Kaua'i Police Department's most important achievements was being awarded accreditation from the Commission on Accreditation for Law Enforcement Agencies (CALEA).

The Office of Professional Standards (OPS) achieved a higher level of accountability for the department by requiring certified instructors to review cases in use of force, vehicle pursuits and police vehicle accidents. In addition, OPS increased station security by updating hardware and software of the department's security systems at Ka Hale Makai O Kaua'i (KPD Headquarters).

The Chief of Police led five (5) community outreach meetings with senior citizens at the Kapa'a, Līhu'e, Kaumakani, Waimea, and Kīlauea neighborhood centers. A total of 117 senior citizens participated. Discussed with the seniors was police recruitment, CALEA accreditation, crime trends and safety tips for seniors.

Patrol Services Bureau (PSB)

The Patrol Services Bureau is responsible for providing first responder police services throughout the island of Kaua'i. They engage in the preservation of the public peace, prevention of crimes, and the pursuit of offenders. PSB enforces State and County laws and ordinances, and protects the rights of individuals.

The bureau is divided into three (3) main districts, Kawaihau, Lihue, and Waimea.

The bureau also has three vital support sections: Traffic Safety Section, Communications/Dispatch Center, and Detention Center/Holding Facility.

The Traffic Safety Section is responsible for traffic enforcement and investigating major traffic collisions involving serious injuries or fatalities. They assist with various community events throughout the island which may have a traffic related concern and conduct car seat checks island-wide.

The Communications/Dispatch Center is responsible for dispatching the entire County of Kaua'i Police, Fire and Medical personnel, as well as other county agencies after hours.

Detention Center/Holding Facility is responsible for providing continuous supervision and security for individuals being held within police custody.

A. Program Objectives - Patrol Services Bureau (PSB):

Patrol Services Bureau Officers respond to calls for services and conduct initial investigations of both criminal and non-criminal incidents.

Officers remain proactive and patrol the island to deter crime, assist when needed and enforce federal, state and local laws.

Officers engage in community oriented policing activities to help collaborate with the public to identify and deter criminal activities

B. Program Highlights - Patrol Services Bureau (PSB):

Personnel from the Patrol Services Bureau attended and/or conducted numerous presentations for community organizations, schools and business related events. As in previous years, there was an effort by officers and supervisors to attend community meetings.

Officers taught students at various schools about seatbelt use, bicycle safety, Halloween safety and personal safety awareness. They also participated in various projects, parades, and numerous community and non-profit fundraisers. PSB personnel also participated in youth sports programs as coaches, referees, and parent volunteers.

Traffic Safety Section personnel directed traffic or closed roads for 27 events which included Hospice Concert in the Sky, Koloa Plantation Days Parade and the Kaua'i Marathon. The Traffic Safety Section officers are certified Child Passenger Safety Technicians. They participated with Child Car Seat events around the island, teaching parents or caregivers with the proper installation of child car seat restraints.

C. Program Activities - Patrol Services Bureau (PSB):

Patrol Services Bureau conducted special projects throughout fiscal year 2017. The following are the projects by districts:

KAWAIHAU DISTRICT

Special Projects accomplished by Kawaihau District Personnel:

- Traffic Enforcement Grant Projects (i.e., Speeding & Seatbelt) conducted at various locations in the Kawaihau District throughout the year resulting in numerous citations for speeding and seatbelt violations.

- Parking Enforcement project after receiving complaints in the Ha'ena and Princeville area, resulted in 831 citations being issued

- Provided traffic safety for "Walk to School Days", School Evacuations and excursions on numerous occasions as St. Catherine's School, Kapaa Elementary School, Kapaa Middle School, Kapaa High School, Hanalei Elementary School and Kilauea Elementary School.
- Pre-shift Briefings were conducted at various locations in the district to help increase visibility and deter crime.
- Officers conducted safety and career presentations at Kauai Independent Daycare Service (KIDS) School & Kauai Christian Academy.
- Officer's conducted a trash cleanup project behind the Kapaa Beach Park Pavilion and Restrooms.
- Officer's participated in the Kauai Youth Football League and Kawaihau Baseball League games and interacted with parents and children.
- Periodic checks were made of hotspots for crime within the district where complaints and frequent incidents were reported.
- Officer's participated in "Shop with a Cop" at Kmart.

LIHUE DISTRICT

Special Projects accomplished by Lihue District Personnel:

- Traffic Enforcement Grant Projects (i.e., Speeding & Seatbelt) conducted at various locations in the Lihue District throughout the year resulting in numerous citations for speeding and seatbelt violations.
- Numerous Impaired Driver Projects conducted at various locations in the Lihue District in attempts to reduce the number of traffic collisions due to intoxicated drivers.
- New Year's Eve project for the purpose of showing presence, respond to & enforce Firework Violations, and other related duties.
- Officers participated in an enforcement project at the Lihue Civic Center resulted in the arrest of 3 subjects for trespass at the Civic Center after business hours.
- An Illegal Vending project was conducted after receiving community complaints on Malo Rd., which resulted in 1 citation being issued.
- Youth Deterrent Projects for underage drinking and smoking conducted island wide.
- Officer's participated in "Shop with a Cop" at Kmart
- An enforcement project was conducted at Hanamaulu Beach, which resulted in three arrests for trespassing in a closed park and several vehicles being towed as derelict or abandoned.
- Officers assisted in the Mayor-a-thon by providing patrols of the area for safety purposes and clearing any safety hazards for participants.
- Special projects were conducted throughout the year which involved checking all parks in the Lihue area to ensure the safety of park goers.

WAIMEA DISTRICT

Investigative Services Bureau (ISB)

The Investigative Services Bureau is responsible for investigating all felony offenses that are referred by the Patrol Services Bureau and may include more complicated misdemeanor offenses. When appropriate, they initiate their own investigations.

The bureau is divided into three (3) Major sections: General Crimes, Special Focus and Vice.

The bureau support sections includes: The School Resource Officer (SRO) Unit, Crime Scene Specialists (CSS), Domestic Violence Intervention Coordinator (DVIC) and Sexual Assault Nurse Examiner (SANE) Program.

The General Crimes Section primarily conducts investigations associated with crimes against persons.

The Special Focus Section primarily conducts investigations associated with crimes against property.

The Vice Section is responsible for investigating and enforcing all laws related to illegal drug activity.

A. Program Objectives - Investigative Services Bureau (ISB):

Bureau investigators are responsible for the preparation of arrest and search warrants, apprehending perpetrators, gathering and preserving evidence, conduct interviews and preparing their respective cases for prosecution.

The Bureau conducted community outreach through informational presentations and is supported by personnel from other Bureaus. Presentations included drug awareness resistance education and theft and burglary prevention in an effort to minimize victimization.

A standby-detective program is in place to ensure an immediate response for after-hour investigations involving major felony offenses and incidents of specific interest.

The Kauai Police Activities League (K-PAL) is active year-round program for adolescents and is devoted to developing character, self-discipline and healthy lifestyles for Kaua'i's youth. K-PAL provides positive role models and Evidence Based Crime and Drug-prevention education through its programs.

The Vice Section conducts investigations of drug offenses at local, state and federal levels. The Vice Section strives to increase the number of drug investigations conducted in an effort to curtail the use, sale, and distribution of illegal narcotics and drugs.

B. Program Highlights - Investigative Services Bureau (ISB):

GENERAL CRIMES SECTION

Search Warrants

In fiscal year 2017, General Crimes Detectives initiated and executed **44** search warrants on homes, vehicles, persons, bags, backpacks, cell phones, and social media accounts from all ten districts on Kaua'i. Numerous items related to evidence of a homicide, attempted homicide, sex assaults, robberies, assaults and other violent crimes were recovered and seized. The recovery of evidence led to numerous arrests and convictions. Some cases are still pending trial.

Special Projects

It has been one year since the Kaua'i Police Department initiated the Lethality Assessment Program (LAP). In partnership with the Hawaii State Coalition Against Domestic Violence, the LAP Program aims to reduce Intimate Partner Violence (IPV) and the lethality associated with violent relationships. During fiscal year 2017, there were 264 lethality screenings conducted at IPV incidents where 145 were deemed as a high danger of lethality. In those cases, 124 individuals received assistance from the Young Women's Christian Association (YWCA).

The Kaua'i Police Department, at the invitation of the Attorney General's Office, participated in a working group regarding the Sexual Assault Kit Initiative (SAKI), House Bill 1907, Act 207. The group developed the State of Hawaii's testing priorities and procedures in regards to the testing of the "untested" Sex Assault Kits (SAK) held in the inventory of law enforcement and advocacy agencies. KPD identified 135 SAK's that required testing. By the end of fiscal year 2017, 47 kits had been sent out for testing to Sorenson Forensics Laboratory.

Major Cases

Murder

Detectives responded to a report of guns shots in the Lihue area. An investigation revealed that an adult male subject shot his ex-wife with a pistol, and then shot himself. Both subjects expired prior to the first responder's arrival. The incident was witnessed by the decedent's juvenile daughter, who was taken into Child Welfare Services custody, and later released to the juvenile's grandfather. Autopsies have been conducted on both decedents. It is apparent that the male subject is the lone shooter/suspect. ISB is continuing to investigate the case in an attempt to conclude the investigation (July 2016).

Detectives responded to an attempted murder in the Kapaa area. Investigation revealed that an adult male reported being shot twice in the upper chest and facial area by one of his live-in roommates, at their place of residence. The 52 year old victim was transported to the hospital and was later transported to Oahu. The suspect fled the scene prior to police arrival to the residence. He was later located and arrested for Attempted Murder in the Second Degree and was held in lieu of \$530,000 bail (October 2016).

Detectives responded to a murder in the Hanapepe area. Investigation revealed that an adult male subject was found deceased in the vicinity of Burn's Field (Port Allen Airport) with multiple gunshot wounds. The 34 year old victim was identified and transported to the Wilcox morgue. Next of kin was notified. Two suspects were arrested and charged with Murder in the Second Degree and both held at Kauai Community Correctional Center (KCCC) in lieu of \$750,000 and \$1,800,100 bail, respectively (November 2016).

Detectives responded to a murder/suicide case in the Hanamaulu area. An investigation revealed that a 67 year old male subject had shot and killed his 40 year old ex-wife following an argument and then turned the gun on himself and committed suicide. Both the victim and the suspect were transported to the Wilcox morgue where autopsies were conducted. The forensic pathologist completed the autopsies and preliminary findings are homicide and suicide (November 2016).

Detectives responded to a stabbing incident in the Hanamaulu area. An investigation revealed that a 37 year old adult female had been stabbed by her 38 year old husband at their residence. The suspect was arrested and charged with Attempted Murder in the Second Degree and is currently being held in lieu of \$510,000 bail (May 2017).

Kidnapping

Detectives responded to a Kidnapping case in the Waimea area. An investigation revealed that the adult female victim had been beaten, choked to unconsciousness and bound with duct tape by her husband. The victim suffered from multiple lacerations, contusions to her facial/neck areas as well as a ruptured eardrum. The suspect was located and admitted to the assault and was arrested and charged with Kidnapping and four (4) counts of Felony Family Abuse. Suspect held in lieu of \$250,000 bail (September 2016).

Sexual Assault

Detectives responded to a Sex Assault case. Investigation revealed that a juvenile male subject reported being sexually assaulted by an adult male subject. A forensic interview was conducted with the victim and a disclosure was made and a 37 year old male suspect was arrested on two (2) counts of Sexual Assault in the Third Degree and posted \$100,000 bail (February 2017).

Detectives responded to a Sex Assault case in the Puhi area. An investigation revealed that an unknown male subject had broken into the residence and sexually assaulted a female juvenile. In the days to follow, ISB identified the adult male suspect and he was arrested and charged with Sexual Assault in the First Degree and Burglary in the First Degree and released pending investigation (May 2017).

Robbery

Detectives responded to a Robbery in the Waimea District. Investigation revealed that an adult male subject walked into a liquor store with a firearm and robbed the establishment. The suspect fled the area on foot and was found hiding in a nearby residence. The suspect, an adult male from Waimea, was arrested and booked for Robbery in the First Degree and is currently being held in lieu of \$50,250 bail (December 2016).

Detectives responded to a bank robbery that occurred in the Lihue area. An investigation revealed that the First Hawaiian Bank on Rice St. had been robbed and an undisclosed

amount of money was taken. The suspect was later located in a residence in the Nawiliwili area and arrested and charged with Robbery in the First Degree and is currently being held in lieu of \$150,000 bail (May 2017).

Promoting Child Abuse

Detectives responded to a Promoting Child Abuse case that occurred on Kaua'i. An investigation revealed that a child pornographic video was circulating throughout Kaua'i. Multiple juvenile suspects were detained on numerous felony and misdemeanor charges related to Child Pornography (August 2016).

Miscellaneous Public Outside Assist

Detectives responded to an Amber Alert that was initiated from the State of Utah. The Salt Lake City Police Department issued the alert that a three (3) year old had been abducted by her mother and was flying into the Lihue Airport. When the flight arrived, the three (3) year old was taken into custody and transferred to her paternal grandparents. The mother was not charged with any criminal offenses based on Utah State's investigation (November 2016).

Missing Person

Skeletal remains were discovered in the Mahaulepu area. The remains were found by an archaeologist hired by Grove Farm to conduct a survey of the area. An investigation revealed that the remains appeared to be that of an adult male subject who was reported missing in the same area in 2016. The skeletal remains were collected with the assistance of the University of Hawaii forensics department and the case has been left pending the positive identification of the deceased (February 2017).

Death Related Report

Detectives responded to a death related case in the Kapaa area. An investigation revealed that two unidentified bodies were located floating in the ocean. The bodies were believed to be two of the three missing fisherman that were reported missing off the island of Oahu. Both bodies were recovered by the Kaua'i Fire Department (KFD) and transferred to KPD custody. An autopsy was conducted, which revealed that the decedents were two of the three missing Oahu fishermen. The third fisherman has not been recovered. The cause of death was ruled as an accidental drowning. Next of Kin was notified. No further investigation conducted (July 2016).

Community Oriented Policing

ISB personnel conducted a two hour presentation at Waimea High School for the Waimea High School Honors Club. The presentation focused on Sex Assaults and the role of the SANE and forensic nurses. There were approximately 15-20 students in attendance and a question and answer session was conducted. (April 2017)

VICE SECTION

Training Provided

Canine handlers conducted a presentation at the Kaua'i Drug Summit with Canine Simon and Canine Tora. The capabilities of the canines were demonstrated for the summit attendees.

High Risk Arrest

The Vice Section and Special Response Team arrested a male subject in the Waimea District. The subject was wanted on a parole violation warrant and was known to be in possession of assault rifles and firearms. Seized inside of the male suspect's vehicle was a Military Armament Corporation Model 10 (MAC-10) type firearm. The firearm was recovered from the back seat area where the male suspect was seated when officers arrived. A female subject was arrested along with the male suspect and both were arrested and charged with Hawai'i Revised Statutes 134-25, Place to keep pistol or revolver. (August 2016)

The Vice section conducted a four day United States (US) Marshals Hawaii Task Force operation targeting fugitives with outstanding State felony arrest warrants. The focus of the operation targeted fugitives wanted for crimes of violence to include homicide, assault, robbery, firearms and explosives, sex offenses and narcotics. The operation resulted in the arrest of 39 fugitives, the execution of 64 outstanding State arrest warrants, and generated a total bail amount of approximately \$698,425 for all warrants executed. In addition to the arrests, officers recovered and seized multiple firearms, various amounts of narcotics, and cash suspected of being associated with criminal activity. The firearms seized were in the possession of a previously convicted felon who is prohibited by law from owning or possessing firearms. The joint efforts of the US Marshals, KPD, US Immigration and Customs Enforcement, the Federal Bureau of Investigation, and the Hawaii High-Intensity Drug Trafficking Area, demonstrated the importance of multi-agency operations and the positive impact they can make in our community. (November 2016)

Vice Officers attempted to arrest a male suspect on a \$2,000 arrest warrant in the Anahola Beach area. Another male subject assisted in the escape of the suspect when he drove the suspect out of the area and attempted to run over officers with his vehicle, sideswiping one of the officers in the process. Both subjects were later indicted by a Grand Jury and arrested. Search warrants were executed on both suspect's vehicles resulting in the seizures of Crystal Methamphetamine and Drug Paraphernalia. Both suspects were initially charged with Attempted Murder in the First Degree on Law Enforcement Officers, Promoting a Dangerous Drug in the Third Degree, Prohibited Acts Related to Drug Paraphernalia, and Promoting a Detrimental Drug in the Third Degree. (February 2017)

Drug investigation

Officers conducted an investigation at the Lihue Airport that resulted in the arrest of four individuals and the seizure of 266.8 grams of Crystal Methamphetamine. (September 2016)

Officers conducted an investigation into a Drug Trafficking Organization (DTO). As a result of the investigation, approximately 132.4 grams of Crystal Methamphetamine and approximately a thousand dollars of U.S. Currency were recovered. (December 2016 & January 2017)

An operation was conducted to purchase three ounces of Methamphetamine from a male subject in the Koloa District. As a result of this operation the male subject was arrested for Promoting a Dangerous Drug in the First Degree and Drug Paraphernalia and a vehicle was seized. Further investigation led investigators to the suspect's residence where, after executing a search warrant on the residence, approximately 5 ounces of Methamphetamine and \$13,000 of cash were seized. The total amount of Crystal Methamphetamine recovered during the course of the investigation was 367 grams (approximately $\frac{3}{4}$ of a pound). This investigation resulted in the successful dismantling of a DTO. (January 2017)

While conducting parcel interdiction at the FedEx sort facility at the Lihue Airport, a parcel was located through a positive canine alert. A search warrant was executed on the parcel and approximately one pound (451.6 grams) of Crystal Methamphetamine was recovered. The parcel was delivered to a male subject at a residence in the Kapaa area. Male subject was later arrested and charged with Promoting a Dangerous Drug in the First Degree and Drug Paraphernalia. A search warrant was executed on the residence. Located within the residence were loaded syringes of Heroin, a white powdery substance, and Crystal Methamphetamine packets of residue. (March 2017)

The Vice Section, along with Drug Enforcement Agency personnel, conducted an investigation of drugs illegally shipped via U.S. Postal. Two parcels addressed to a female suspect were alerted to by canine screening. Federal search warrants were executed on the parcels resulting in the recovery of approximately one ounce of Heroin in one parcel, and approximately 8 ounces of Methamphetamine in the second parcel. (April 2017)

Further investigation led to seizures of an additional two (2) ounces of Methamphetamine, approximately one (1) pound of Marijuana, fifteen (15) grams of Heroin, and approximately \$8,000.00 in cash. (April 2017)

SPECIAL FOCUS SECTION

Major Cases

Theft

An adult female was located and arrested in the Kawaihau District in regards to a felony theft complaint. The female suspect was allegedly using an elderly female's bank account to pay for goods and services without permission. The suspect was released pending further investigation. (December 2016)

An adult male was arrested for Theft in the Second Degree in the Kawaihau District. The male suspect was located in the possession of a stolen bicycle from a residential burglary in the Kawaihau District. The suspect admitted to being in possession of the stolen bicycle, but denied knowing the bicycle was stolen, or burglarizing the residence. The stolen bicycle was recovered and suspect was released on bail. (March 2017)

An adult female was arrested for Forgery in the Second Degree and Theft in the Second Degree in regards to crimes committed in the Waimea District. The suspect was questioned, and admitted to the above-mentioned charges. The suspect knowingly and intentionally stole money from her employer and attempted to conceal her crimes. The suspect was released pending further investigation, and several additional charges are pending. (March 2017)

An adult female was arrested for Theft in the First Degree and Falsifying Business Records in regards to crimes committed in the Lihue District. The suspect was questioned by detectives and admitted to the above-mentioned charges. The suspect knowingly and intentionally stole money from her employer and attempted to conceal her crimes. The suspect was released pending further investigation, and several additional charges are pending. (March 2017)

An adult male suspect was arrested in the Kawaihau District for Theft in the Fourth Degree, and two outstanding bench warrants. A search warrant was executed on the suspect's bag and 13.8 grams of Marijuana and .4 grams of Heroin were seized. The suspect is currently incarcerated at Kauai Community Correctional Center. (June 2017)

Unauthorized Control of a Propelled Vehicle

An adult male was arrested in the Kawaihau District in regards to an Unauthorized Control of a Propelled Vehicle complaint. The suspect was advised of his rights and provided a verbal statement. The suspect denied the allegations and was released pending further investigation. A search warrant was executed on the stolen vehicle and items linking the suspect to the crime were located within the vehicle. (December 2016)

An adult male was arrested in the Lihue District for the offense of Unauthorized Control of a Propelled Vehicle. The male suspect was questioned by detectives and admitted to being in possession of the stolen vehicle. The vehicle was returned to the owner. (March 2017)

An adult female suspect was arrested in the Kawaihau District for Unauthorized Control of a Propelled Vehicle. The suspect was advised of her constitutional rights, and refused to provide a statement to the investigating detective. The suspect was held at Kauai Community Correctional Center. (May 2017)

Burglary

An adult male was arrested for burglarizing a business in the Waimea District. The items stolen were recovered and returned to the owner. The suspect was extradited to California on separate charges. (February 2017)

An adult male was arrested for attempted burglary for two (2) businesses in the Kawaihau District. The suspect was questioned and confessed to the crimes. (February 2017)

An adult male was arrested for Burglary in the First Degree in the Koloa District. The male suspect was observed exiting a guest's hotel room, and fled the scene. The suspect was subsequently located, and arrested. The victim's belongings were located in the truck bed of the suspect's vehicle, and returned to the victim. (March 2017)

An adult male, adult female, and a juvenile female were arrested in the Kawaihau District for Burglary in the First Degree. The suspects were advised of their constitutional rights, questioned by detectives, and confessed to gaining access into a hotel room without permission. The adults are currently held at the Kauai Community Correctional Center. The juvenile female was identified as a runaway from the Big Island, and Child Welfare Services was notified and made arrangements to transport the juvenile back to the Big Island. (June 2017)

An adult male suspect was arrested in the Kawaihau District for Burglary in the Second Degree, Theft in the Third Degree, Promoting a Dangerous Drug in the Third Degree, and Possessing Drug Paraphernalia. The arrests originated from a burglary that occurred at a hotel in the Kawaihau District. The male suspect was in possession of the stolen items from the burglary. The suspect is currently incarcerated at the Kauai Community Correctional Center. (June 2017)

Sexual Assault / Family Abuse

An adult male was arrested for Assault in the First Degree, Kidnapping, Abuse of a Family Member, Burglary in the First Degree, and Criminal Trespassing in the First Degree. The incident and arrest occurred in the Kawaihau District. The male suspect was involved in a verbal altercation with his ex-girlfriend, and the incident escalated into a physical altercation. The suspect was located, and arrested. The suspect was held at the Kauai Community Correctional Center. (April 2017)

A Detective participated in a two (2) day Sex Offender Registry Compliance Project with the US Marshall Service in which seventeen (17) sex offenders were contacted and found to be in compliance.

C. Program Activities - Investigative Services Bureau (ISB):

Special Projects accomplished by Investigative Services Bureau Personnel:

- Conducted Drug Abuse Resistance Education (DARE) classes to 7th graders at Kapaa Middle School, Chiefess Kamakahelei Middle School, Waimea Canyon Middle School and St. Teresa's Catholic School.
- Conducted numerous youth deterrent projects which results in the detainment and citation of numerous subjects for various offenses.
- Conducted numerous Tobacco Sales projects which resulted in the citation of numerous individuals and establishments.
- K-PAL (Kaua'i Police Activities League) serviced approximately 2,100 juveniles, through basketball, boxing, flag football and wrestling programs.
- Community outreach presentations were conducted which included:
 - Crime prevention presentations
 - Halloween Safety
 - Neighborhood Watch
 - Safety Talks for Schools and Seniors
 - Career Days/Fairs
 - Police Station Tours

Administrative and Technical Bureau (ATB)

The Administrative and Technical Bureau is responsible for training, equipment, recruitment and provides support services to other police bureaus within the department.

The bureau is divided into two (2) main sections: Training Section and Research & Development.

The bureaus support sections include: Fiscal/Personnel Section, Records Section, Fleet Coordinator and Abandoned/Derelict Vehicle Coordinator.

The Training Section is responsible for planning and coordinating training for both sworn and civilian personnel.

The Research and Development Section is responsible for procuring uniforms and equipment, assisting with department inventory and recruitment and hiring.

A. Program Objectives – Administrative and Technical Bureau (ATB):

Effectively maintain and manage the following; police records, information systems, fingerprinting and photographic services, evidence storage, documentation regarding service of warrants and legal documents, issuance of permits and registration of firearms.

Assist in the development of efficient and professional police personnel by developing and coordinating training programs including; recruit training, in service training, emergency vehicle operations, self- defense, firearms, forensics, sexual harassment and supervisory training.

Continue assessing computer needs for the department to enhance operational efficiency, including the Computer Aided Dispatch (CAD) and Records Management System (RMS) systems.

Continue to seek potential funding for the department via Federal and State Grants.
Recruit, screen, and hire suitable and qualified personnel to fill vacancies within the department.

Negotiate, procure and manage a variety of KPD contracts.

B. Program Highlights - Administrative and Technical Bureau (ATB):

The Kaua'i Police Department, Spillman Technologies, County Attorney's Office, Kaua'i Fire Department, and the Finance Department's Division of Purchasing and Information Technology Division worked diligently to "go live" with the new Spillman Computer Aided Dispatch (CAD), Records Management System (RMS) and Mobile software system. The systems went "live" on December 5, 2016. Spillman enhances KPD's ability to provide the highest levels of service to the community. The implementation of Spillman and its various modules was over 80% complete by the end of the fiscal year.

THE RESEARCH & DEVELOPMENT SECTION:

During the 2017 fiscal year, KPD hired seven (7) new police officers that were assigned to the Patrol Services Bureau. In an effort to reduce overtime, KPD trained and assigned the new hires to work in cellblock prior to the Police Academy start date. This new practice saved the County of Kaua'i thousands of dollars in overtime costs and provided the new hires with on the job experience. This practice also allows more experienced officers to work patrol instead of cellblock. With the infusion of the new officers into the patrol schedule, overtime expenditures have been reduced in the area of cancelled days off to cover basic services.

TRAINING SECTION:

Department wide Annual Recall Training continues to be successful in providing the most up-to-date information to KPD's personnel. The curriculum included range qualifications, reality based scenario training, physical fitness testing, and pressure point control tactics.

Grant Projects FY2017

The Project Manager in each program is responsible for acquiring State and Federal grant revenue funds. Most grants extend over multiple years. The Administrative and Technical Bureau is accountable for the fiscal reporting and tracking of the following grant awards.

1. State Highways Special Enforcement (State DOT - \$542,842):
Law enforcement and public education relating to distracted driving; deter drivers from drinking and driving, enforce underage drinking, enforce seatbelt and speeding laws and provide training for Traffic Safety Unit officers.
2. 911 Emergency Medical Services (State Department of Health - \$179,900):
To operate a central 911 and dispatch communications center for emergency medical ambulance service.
3. Statewide Marijuana Eradication Task Force (State Attorney General - \$40,757):
To eradicate marijuana in Hawaii through a multi-agency/multi-jurisdictional cooperative effort.
4. Hawaii Narcotics Task Force (State Attorney General - \$31,433):
To prohibit drugs in the State by counteracting smuggling of narcotics via apprehension and conviction.
5. Domestic Cannabis Eradication/Suppression Program (U.S. Department of Justice- \$25,000):
To eradicate illegal cultivation of marijuana.
6. High Intensity Drug Trafficking Area HI-IMPACT (Office of National Drug Control Policy - \$256,305):
To combat the drug problem, specifically that of Crystal Methamphetamine.
7. State Law Prohibiting Tobacco Sales to Minors (Department of Health - \$10,000):
To reduce tobacco sales to minors.
8. SANE Recruitment, Training & Standby (State Attorney General - \$48,595):
To strengthen County of Kaua'i response to adolescent and adult female victims of sexual assault by recruiting, training and retaining new SANEs (Sexual Assault Nurse Examiners), and by providing continuing educations to current SANEs and sex crimes investigators.
9. SANE Exams and DNA Analysis (State Attorney General - \$47,695):
To provide SANE (Sexual Assault Nurse Examiners) exams to all adolescent and adult female victims of sexual assault according to the statewide examination criteria developed and adopted by members of HSART (Hawaii Sexual Assault Response Team), and to analyze forensic evidence to assist in the investigation.
10. COPS Hiring Program Grant (Department of Justice - \$750,000):
Increase the number of first responders by six (6) officers for the Kaua'i Police Department to allow a more even distribution of caseloads among officers while promoting community policing strategies aimed to prevent, solve and control crime.

11. Bulletproof Vest Partnership (Department of Justice - \$7,215):
Reimburse Kaua'i Police Department 50% of the cost of replacement bulletproof vests for the safety of the officers.
12. Joint Force Reimbursements (Department of Justice - \$15,937):
Overtime reimbursement for the joint efforts of cross jurisdictional operations with FBI, DEA, US Marshals etc.

Enhanced 911 Fund

The Enhanced 911 Fund was established in accordance with Act 159/SLH 2004, as a special fund outside of the state treasury, to be administered by the Enhanced 911 Board. The fund consists of monthly surcharge collections imposed on each Commercial Mobile Radio Service (CMRS) connection (wireless telephones and similar devices). The Administrative & Technical Bureau's Assistant Chief represents the County of Kaua'i at the State of Hawai'i Enhanced-911 Board meeting and Technical and Finance Committee meetings each month. The ATB Bureau is also responsible for the submittal of reimbursement requests to the Enhanced 911 Board for corresponding expenditures detailed below.

1. Akimeka, LLC. - \$211,880:
Provides continued Wireless Enhanced 9-1-1 (E9-1-1) Program Management and Geographic Information System (GIS) Services for Neighbor Island Counties to support on-going operations and maintenance of their E9-1-1 system
2. Hawaiian Telcom - \$564,215:
Hawaiian Telcom Intrastate Tariff Charges charged for each Cache Meta Language (CML) position housed in a Public Safety Answering Point (PSAP) and the Alternate Dispatch Center (ADC) is reimbursed by the Wireless Enhanced Board Funds. This service through Hawaiian Telcom is necessary in order to receive emergency 911 calls. The Hawaiian Telcom trunk charges are the only mechanism for the PSAPs to receive emergency 911 calls. Without this service, none of the emergency responders would be able to respond to emergency 911 calls.
3. Travel - \$22,541:
Provides funding for County of Kaua'i representatives to travel to attend the monthly board meetings and annual training conference, which is reimbursed by the Wireless Enhanced Board funds.
