SPECIAL INSPECTIONS FORM 2018 INTERNATIONAL BUILDING CODE, Sections 1704 and 1705 Hawai'i State Building Code Adoption as adopted on April 20, 2021

Where application is made to the building official for construction, the owner or the registered design professional in responsible charge acting as the owner's authorized agent, shall employ one or more special inspectors independent of the contractors performing the work to provide special inspections and tests during the construction on the types of work specified in Section 1705 and identify the special inspectors to the building official. These special inspections and tests are in addition to the inspections by the building.
