[Bill No. 2666](#) A BILL FOR AN ORDINANCE TO AMEND CHAPTER 7, ARTICLE 1, KAUA‘I COUNTY CODE 1987, AS AMENDED, RELATING TO THE UPDATE OF THE GENERAL PLAN FOR THE COUNTY OF KAUA‘I (ZA-2017-3) (**Public hearing held on October 4, 2017**) (*Copies of the Draft Ordinance for Zoning Amendment (ZA-2017-3) including the Commission’s Draft of the General Plan and Accompanying Appendices, on file in the Office of the County Clerk.*)

  - Following the initial opportunity for public testimony, Councilmembers may proceed to introduce and discuss amendments to [Kaua‘i Kākou - Kaua‘i County General Plan \(Planning Commission Draft \(June 2017\)\)](#) and [Appendices](#).
  - Following the second opportunity for public testimony (available only for those who did NOT speak at the beginning of the meeting), Councilmembers will vote on the amendments and may introduce new or additional amendments.
