Bill No. 2762

A BILL FOR AN ORDINANCE AMENDING ORDINANCE NO. B-2019-856, AS AMENDED, RELATING TO THE OPERATING BUDGET OF THE COUNTY OF KAUAI, STATE OF HAWAII, FOR THE FISCAL YEAR JULY 1, 2019 THROUGH JUNE 30, 2020, BY REVISING THE AMOUNTS ESTIMATED IN THE GENERAL FUND (*Office of the Prosecuting Attorney, Victim Witness Counselor II Positions - \$23,069.00*)

This Bill proposes to amend Ordinance No. B-2019-856, as amended, relating to the Operating Budget of the County of Kaua'i, State of Hawaii, for the Fiscal Year July 1, 2019 through June 30, 2020, by revising the amounts estimated in the General Fund. The purpose of this Bill is to reallocate a portion of "Regular Salaries" account funds appropriated for Position No. 2804, Victim Witness Counselor II, to other Victim Witness Counselor II positions, identified in the budget as Position Nos. 2824 and 2825, which will allow all Victim Witness Counselors to service all victims without limitation.

All interested persons who wish to present their comments may do so at the public hearing. Written testimony prior to the hearing would be appreciated. Written testimony can be submitted to the Office of the County Clerk, Council Services Division by mail, facsimile, or via E-mail to counciltestimony@kauai.gov. Copies of the Bill are available at the Office of the County Clerk, Council Services Division.

(The Council Committee or Council may amend this Bill at their subsequent meetings. Meeting notices are posted at least six (6) days in advance at the County Clerk's Office and the public may also testify at any of these meetings.)

AS AMENDED, RELATING TO THE OPERATING BUDGET

SECTION 1. Be and is hereby appropriated for the following purposes:

Office of the Prosecuting Attorney, Regular Salaries

Position No. 2824 – Victim Witness Counselor II \$5,940.00

Position No. 2825 – Victim Witness Counselor II \$17,129.00


