A BILL FOR AN ORDINANCE AMENDING ORDINANCE NO. B-2019-856, AS AMENDED, RELATING TO THE OPERATING BUDGET OF THE COUNTY OF KAUAI, STATE OF HAWAII, FOR THE FISCAL YEAR JULY 1, 2019 THROUGH JUNE 30, 2020, BY REVISING THE AMOUNTS ESTIMATED IN THE HIGHWAY FUND (*Waimea River Mouth Emergency Work - \$625,000.00*)

The purpose of this Bill is to request Council approval to replenish funds in the amount of \$245,000.00 that the Department of Public Works has expended on emergency work required at the Waimea River Mouth. The remaining request of \$380,000.00 is intended to cover future work on the Waimea River through the end of Fiscal Year 2019-2020. Such work includes design and engineering services, maintenance of the levy's gates, and other services.

All interested persons who wish to present their comments may do so at the public hearing. Written testimony prior to the hearing would be appreciated. Written testimony can be submitted to the Office of the County Clerk, Council Services Division by mail, facsimile, or via E-mail to counciltestimony@kauai.gov. Copies of the proposed Bill are available at the Office of the County Clerk, Council Services Division.

(The Council Committee or Council may amend this Bill at its subsequent meetings. Meeting notices are posted at least 6 days in advance at the County Clerk's Office and the public may also testify at any of these meetings.)

**A BILL FOR AN ORDINANCE AMENDING ORDINANCE NO. B-2019-856,
AS AMENDED, RELATING TO THE OPERATING BUDGET
OF THE COUNTY OF KAUAI, STATE OF HAWAII,
FOR THE FISCAL YEAR JULY 1, 2019 THROUGH JUNE 30, 2020,
BY REVISING THE AMOUNTS ESTIMATED IN
THE HIGHWAY FUND**

BE IT ORDAINED BY THE COUNCIL OF THE COUNTY OF KAUAI, STATE OF HAWAII:

SECTION 1. That pursuant to Sections 19.07B and 19.10A of the Charter of the County of Kauai, as amended, Ordinance No. B-2019-856, as amended, relating to the Operating Budget of the County of Kauai, State of Hawaii, for the Fiscal Year July 1, 2019 through June 30, 2020, be hereby amended as follows:

The sum of \$625,000.00 by revising the amounts estimated in the Highway Fund from the following account:

Equity / Fund Balance, Assigned [\$625,000.00]

Be and is hereby appropriated for the following purposes:

Department of Public Works, Roads Maintenance Other \$200,000.00
Other Services – Replenish River Mouth Emergency Work and Maintenance
Through Fiscal Year 2020

Department of Public Works, Roads Administration \$45,000.00
Other Services - Replenish River Mouth Emergency Work

Department of Public Works, Roads Maintenance Other \$380,000.00
Other Services - Design & Engineering Services to Address Flooding Issues
Caused by the Waimea River to Homes Near the Levy

SECTION 2. This Ordinance shall take effect upon its approval.


