This Bill proposes to amend Ordinance No. B-2019-856, as amended, relating to the Operating Budget of the County of Kaua'i, State of Hawaii, for the Fiscal Year July 1, 2019 through June 30, 2020, by revising the amounts estimated in the Housing Development Fund. The purpose of this Bill is to establish revenue and expenses to maintain 417 acres of land purchased in Waimea, to include regular mowing, canal cleaning, and security.

AS AMENDED, RELATING TO THE OPERATING BUDGET OF

BE IT ORDAINED BY THE COUNCIL OF THE COUNTY OF KAUA'I, STATE OF HAWAII:

SECTION 1. That pursuant to Sections 19.07B and 19.10A of the Charter of the County of Kaua'i, as amended, Ordinance No. B-2019-856, as amended, relating to the Operating Budget of the County of Kaua'i, State of Hawaii, for the Fiscal Year July 1, 2019 through June 30, 2020, be hereby amended as follows:

The sum of \$47,268.00 by revising the amounts estimated in the Housing Development Fund from the following account:

Be and is hereby appropriated for the following purpose:

Housing Support / Other Services \$47,268.00
(Waimea Parcel – Canal Cleaning)

The sum of \$182,732.00 by revising the revenue estimated in the Housing Development Fund in the following account:

Rents & Concessions / Other Rentals (Waimea Parcel) \$182,732.00

Be and is hereby appropriated for the following purposes:

Housing Support / Other Services \$152,732.00
(Waimea Parcel – Canal Cleaning)

Housing Support / Other Services \$30,000.00
(Waimea Parcel – Mowing / Security)


