A BILL FOR AN ORDINANCE AMENDING ORDINANCE NO. B-2020-866, AS AMENDED, RELATING TO THE OPERATING BUDGET OF THE COUNTY OF KAUAI, STATE OF HAWAII, FOR THE FISCAL YEAR JULY 1, 2020 THROUGH JUNE 30, 2021, BY REVISING THE AMOUNTS ESTIMATED IN THE GENERAL FUND (*Transient Accommodations Tax Revenue Reduction (Second Half of the Year) – \$7,467,500.00*)

This Bill proposes to amend Ordinance No. B-2020-866, as amended, relating to the Operating Budget of the County of Kaua'i, State of Hawaii, for the Fiscal Year July 1, 2020 to June 30, 2021, by revising the amounts estimated in the General Fund by appropriating \$7,467,500.00 from the Equity / Fund Balance – Unassigned to the Inter-Governmental Revenues – State Grant-In-Aid – State Transient Accommodations Tax (TAT) to fund the shortfall anticipated for the second half of the year (through June 30, 2021) due to COVID-19.

All interested persons who wish to present their comments may do so at the public hearing. Written testimony prior to the hearing would be appreciated. Written testimony can be submitted to the Office of the County Clerk, Council Services Division by mail, facsimile, or via E-mail to counciltestimony@kauai.gov. Copies of the Bill are available at the Office of the County Clerk, Council Services Division.

(The Council Committee or Council may amend this Bill at their subsequent meetings. Meeting notices are posted at least six (6) days in advance at the County Clerk's Office and the public may also testify at any of these meetings.)

Inter-Governmental Revenues \$7,467,500.00
State Grant-In-Aid – State Transient Accommodations Tax (TAT)


