Bill No. 2733

A BILL FOR AN ORDINANCE AMENDING ZONING DESIGNATION IN KAPAHI, KAUA'I (*Baird Family Limited Partnership, Applicant*) (ZA-2018-1)

This Bill proposes to amend Zoning Map ZM-500 and a portion of property (approximately 1.98 acres), identified as Tax Map Key No. (4) 4-4-013:002, from County-zoned "Open District" to "Agriculture District," subject to the condition stated in the Bill. The applicant is Baird Family Limited Partnership.

All interested persons who wish to present their comments may do so at the public hearing. Written testimony prior to the hearing would be appreciated.
