

MINUTES

PUBLIC WORKS / PARKS & RECREATION COMMITTEE

March 2, 2016

Committee Chair Kagawa: My plan is to defer all items.

PWPR 2016-03 Communication (02/04/2016) from Committee Chair Kagawa, requesting the presence of the County Engineer and Deputy County Engineer, to discuss the circumstances relating to the Management Advisory Report for the Fiscal Year Ended June 30, 2015, Current Findings and Recommendations, 2015-003 (Improve Monitoring of Delinquent Receivable Accounts). **(This item was Deferred.)**

PWPR 2016-04 Communication (02/18/2016) from Council Chair Rapozo, requesting the presence of the Acting County Engineer, to provide a briefing and status update on the Hanapēpē Bridge. **(This item was Deferred.)**

Bill No. 2612 A BILL FOR AN ORDINANCE TO AMEND CHAPTER 14, KAUAI COUNTY CODE 1987, AS AMENDED, RELATING TO THE PLUMBING CODE **(This item was Deferred.)**

Committee Chair Kagawa: Before the motion to defer is made, I just want to say *mahalo* to Lyle and the Buildings Division for seeking out the input as I had ask for them to go out and talk to the contractors and Contractors Association of Kaua'i and just abreast them of the changes to the Plumbing and Electrical Codes.
