I. Mission Statement

It is our mission to promote the fair, impartial and expeditious pursuit of justice in every case, to ensure safer communities, and to promote integrity in our profession. It is our mission to temper justice with compassion, and to do our work in an open, transparent, and accountable way.

II. Departmental Goals

A. Diligently represent the County of Kaua`i and the State of Hawai`i in the prosecution of all offenses arising under the laws of the State and the ordinances and regulations of the county of Kaua`i in a swift manner, and to ensure justice is served in each case.

B. Advocate for crime victims' rights and ensure that victims have an active voice in the criminal process by maintaining a fully functional Victim/Witness Program (VWP).

C. Maintain close relationships with local, state, and federal law enforcement agencies to ensure successful prosecution of criminal offenses and increasing presence and participation at the State Legislature to ensure a coherent legislative agenda regarding public safety.

D. Develop community-oriented prosecution by strengthening outreach, accessibility, and participation.

E. Maintain a high level of ethical integrity and professionalism.

F. Practice effective fiscal management and strive to achieve optimum levels of operational efficiency. Seek to enhance grant funding from state and federal entities.

III. Program Description

A. Case Management and Workflow

1. Goals for FY '18
 - a) Continue utilization of the Journal Technologies JustWare Case Management System (CMS) to:
 - (1) Increase efficiency in document generation.
 - (2) Implement electronic interface with KPD RMS.
 - b) Continue work improvements of paperless workflow (receive reports from KPD electronically instead of hardcopy, provide discovery to defense bar electronically instead of hardcopy);
 - c) Mobile solutions (continue attorney training on ways to maximize utilization of CMS on tablet devices so that productivity continues regardless of location).
 - d) Roll-out DPA access to online/electronic transmission of Body Worn Camera (BWC) videos from KPD.
 - e) Roll-out Defense bar access to BWC videos as discovery instead of providing OPA-created DVD copies.

B. Victim/Witness Program (VWP)

1. Goals for FY '18
 - a) Create a more confidential and discreet working environment to serve victims/witnesses.
 - b) Improve the Victim/Witness Program by adding a new VW Counselor and administrative support position.
2. Accomplishments
 - a) Provided increased levels of direct services to victims.
 - b) Received a wider range of automatic case assignments
 - c) Utilized grant funds to participate in trainings to facilitate professional growth amongst staff.
 - d) Enhances relationships and partnerships with related County and State agencies as well as non-profit service providers.

C. Legislation

1. Goals for FY '18
 - a) Continue leveraging our partnerships with local legislators to strengthen existing crime laws.
 - b) Lobby for increased protection for victims of domestic violence.
 - c) Support Constitutional Amendment establishing Crime Victim Rights. Hawaii is one of 17 states without a Constitutional Amendment guaranteeing specific rights of crime victims and their immediate surviving family members.
 - d) Work closely with Hawai'i Prosecuting Attorney's Association (HPAA) and Law Enforcement Coalition (LEC) partners to support a coherent legislative agenda.
2. Objectives
 - a) Utilize and maintain the Hawai'i Legislative Tracker system to track and manage the activity of bills, status on testimony, and opportunity to partner with other agencies toward common goals.
 - b) Engage the community in OPA's legislative activity and provide updates at community meetings on the impacts of proposed legislation on public safety.

D. Property Crime Prosecution

1. Goals for FY '18
 - a) Continue leveraging community partnerships to identify and apprehend property crime ring masterminds and ringleaders.
 - b) Continue to prioritize screening and charging of property cases.
 - c) Work with KPD to track and analyze property crime trends.
2. Objectives
 - a) Partner with community organizations and law enforcement to recognize and respond to trends.
 - b) Civil nuisance abatement of "drug houses" - which have a direct and indirect impact on property crimes.

3. Accomplishments
 - a) Successful leveraging of plea agreements to convict property offenders and obtain restitution for victims of property crimes.
 - b) Successful Career Criminal trial prosecution of a repeat property offender.

E. Community- Oriented Prosecution

1. Goals for FY '18
 - a) Continue and strengthen community outreach and listening efforts by participating in community/neighborhood group meetings.
 - b) Respond to inquiries for services and information.
2. Objectives
 - a) Attend community and/or Mayor's Community meetings.

F. Support Staff

1. Goals for FY '18
 - a) Continue to timely and proficiently provide support and assistance for the Office.
2. Objectives
 - a) Cross-train support staff.
 - b) Provide training opportunities and continual support in learning all software systems utilized by OPA, KPD, and Judiciary.

G. Office Space and Facilities
