The Police Commission consists of seven members who are appointed by the Mayor and confirmed by the County Council. The Commission adopts rules as it may consider for the conduct of its business and regulations of matters relating to the goals and aims of the department. (Article XI 11.03.A)

Appointments are for a three-year term with a maximum of two terms.

The Police Commission receives, considers and investigates charges brought by the public against the conduct of the department or any of its members. The Commission is also responsible for reviewing the annual budget. (Article XI 11.03.B/C)

OFFICE OF THE CHIEF OF POLICE

The Chief of Police is responsible for the preservation of the public peace, protection of the rights of persons and property, prevention of crime, detection and arrest of offenders, and enforcement of all laws of the State and County ordinances and all rules and regulations.

The Chief of Police is responsible to equip, train, maintain and supervise a force of police officers and civilian staff. The Chief is also responsible for the serving of processes and notices both in criminal and civil proceedings.

The Chief of Police plans, organizes staffs, directs and controls the personnel and resources of the department, and administers the department in a manner consistent with the Charter of the County of Kaua'i and the laws of the State of Hawai'i.

The Office of the Chief of Police provides overall direction and supervision to all of the sub-units and personnel of the department. It establishes departmental goals and priorities and monitors the progress of bureaus in attaining these goals. It also directs and supervises the information gathering and enforcement efforts of the Criminal Intelligence Unit (CIU) and Office of Professional Standards (OPS), which investigates complaints against police officers.

A. Program Objectives – Office of the Chief of Police:

To enhance and institutionalize the philosophy of Community Policing and the creation of a positive and pro-active partnership between police officers and our citizens; to be responsive to the needs of our community.

To increase positive interactions and programs with and for the youth of our community to reduce the probability of youth crimes.

To develop and promote an internal work environment based on mutual respect, dignity, and trust; to ensure that all employees are treated fairly and equitably.

To provide efficient law enforcement to prevent criminal behavior, and to apprehend those responsible for criminal acts.

To persistently pursue and obtain the resources, training, and equipment needed by our employees to maximize their efficiency and effectiveness.

The Kaua'i Police Department supports the belief that there is a direct correlation between an increase in drug arrests and seizures, and subsequent decrease in the number of overall crimes. To this extent, we remain committed to ensuring that all possible efforts will be taken to reduce drug related elements within the Community.

The amount of new hires, especially police officers, continues to be a reflection of the positive strides being made in this area. However, keeping pace with retirement and other attrition factors have been and will remain a challenge in fiscal year 2018.

B. Program Highlights - Office of the Chief of Police

One of the Kaua'i Police Department's most important achievements was being awarded accreditation from the Commission on Accreditation for Law Enforcement Agencies (CALEA).

The Office of Professional Standards (OPS) achieved a higher level of accountability for the department by requiring certified instructors to review cases in use of force, vehicle pursuits and police vehicle accidents. In addition, OPS increased station security by updating hardware and software of the department's security systems at Ka Hale Makai O Kaua'i (KPD Headquarters).

The Chief of Police led five (5) community outreach meetings with senior citizens at the Kapa'a, Lihu'e, Kaumakani, Waimea, and Kīlauea neighborhood centers. A total of 117 senior citizens participated. Discussed with the seniors was police recruitment, CALEA accreditation, crime trends and safety tips for seniors

PATROL SERVICES BUREAU (PSB)

The Patrol Services Bureau is responsible for providing first responder police services throughout the island of Kaua'i. They engage in the preservation of the public peace, prevention of crimes, and the pursuit of offenders. PSB enforces State and County laws and ordinances, and protects the rights of individuals.

The bureau is divided into three (3) main districts, Kawaihau, Lihue, and Waimea.

The bureau also has three vital support sections: Traffic Safety Section, Dispatch Center and Detention Center.

The Traffic Safety Section is responsible for traffic enforcement and investigating major traffic collisions involving serious injuries or fatalities. During the fiscal year the traffic unit investigated two (2) traffic collisions which resulted in fatalities. They assist with various

community events throughout the island, which may have a traffic related concern, and conduct car seat checks island-wide.

The Dispatch Center is responsible for dispatching the entire County of Kaua'i Police, Fire and Medical personnel, as well as other county agencies after hours.

The Detention Center is responsible for providing continuous supervision and security for individuals being held within police custody.

A. Program Objectives - Patrol Services Bureau (PSB):

Patrol Services Bureau Officers respond to calls for services and conduct initial investigations of both criminal and non-criminal incidents.

Officers remain proactive and patrol the island to deter crime, assist when needed and enforce federal, state and local laws.

Officers engage in community oriented policing activities to help collaborate with the public to identify and deter criminal activities

B. Program Highlights - Patrol Services Bureau (PSB):

Personnel from the Patrol Services Bureau attended and/or conducted numerous presentations for community organizations, schools and business related events. As in previous years, there was an effort by officers and supervisors to attend community meetings.

Officers taught students at various schools about seatbelt use, bicycle safety, Halloween safety and personal safety awareness. They also participated in various projects, parades, and numerous community and non-profit fundraisers. PSB personnel also participated in youth sports programs as coaches, referees, and parent volunteers.

C. Program Activities - Patrol Services Bureau (PSB):

Patrol Services Bureau conducted special projects throughout fiscal year 2018. The following are the projects by districts:

Traffic Safety

Special Projects accomplished by Traffic Safety Personnel:

- Assisted with Hospice Concert in the Sky.
- Assisted with Koloa Plantation Days Parade
- Assisted with the Kaua'i Marathon.

- Conducted Child Car Seat events around the island to include the Tutu and Me Program and Wilcox Hospital birthing section. These events teaches parents or caregivers the proper installation of child car seat restraints.

Kawaihau District

Special Projects accomplished by Kawaihau District Personnel:

- Traffic Enforcement Grant Projects (i.e., Speeding & Seatbelt) conducted at various locations in the Kawaihau District throughout the year resulting in 87 citations for speeding and 112 seatbelt violations.
- Numerous Impaired Driver Projects conducted at various locations in the Kawaihau District in attempts to reduce the number of traffic collisions due to intoxicated drivers.
- Parking Enforcement project after receiving complaints in the Ha'ena and Princeville area, resulted in 1246 citations being issued
- New Year's Eve project for the purpose of responding to & enforcement of Firework Violations, and other related duties.
- Provided traffic safety for "Walk to School Days", School Evacuations and excursions on numerous occasions as St. Catherine's School, Kapa'a Elementary School, Kapa'a Middle School, Kapa'a High School, Hanalei Elementary School and Kilauea Elementary School.
- Pre-shift Briefings were conducted at various locations such as Kapa'a Pool and Keālia Beach to help increase visibility and deter crime.
- Periodic checks were made of hotspots for crime within the district where complaints and frequent incidents were reported. Areas such as Keālia and Anahola Beaches, as well as behind Kapa'a Pool and Kapa'a Lihi are done daily on each shift.
- Officers conducted roadblocks and security checkpoints in response to recent damages due to flooding in the Hanalei, Wainiha and Hā'ena areas.

Lihue District

Special Projects accomplished by Lihue District Personnel:

- Traffic Enforcement Grant Projects (i.e., Speeding & Seatbelt) conducted at various locations in the Lihue District throughout the year resulting in numerous citations for speeding and seatbelt violations.
- Numerous Impaired Driver Projects conducted at various locations in the Lihue District in attempts to reduce the number of traffic collisions due to intoxicated drivers.
- New Year's Eve project for the purpose of showing presence, respond to & enforce Firework Violations, and other related duties.
- Officers participated in an enforcement project at the Lihue Civic Center and Historic County Building after business hours. No citations issued.
- An Illegal Vending project was conducted after receiving community complaints on Maalo Rd., which resulted in no citation being issued.
- Youth Deterrent Projects for underage drinking and smoking conducted island wide.

- Officer's participated in "Shop with a Cop" at Kmart
- Special projects were conducted throughout the year, which involved checking all parks in the Lihue area to ensure the safety of park goers.
- Provided traffic safety for "Walk to School Days", School Evacuations and excursions on numerous occasions as St. Catherine's School, Kapa`a Elementary School, Kapa`a Middle School and King Kaumualii Elementary School.
- Officers conducted safety and career presentations to several Cub Scout Troops in the Lihue area.
- Lihue District Officers along with other Units from The Kauai Police Department, Kauai Sherriff's Department, State Department of Land and Natural Resources (DOCARE) conducted a project to remove illegal occupiers of the Coco Palms Resort property. One person was arrested for trespassing.

Waimea District

Special Projects accomplished by Waimea District Personnel:

- Traffic Enforcement Grant Projects (i.e., Speeding & Seatbelt) conducted at various locations in the Waimea District throughout the year resulting in numerous citations for speeding and seatbelt violations. Enforcement also conducted around schools.
- Numerous Impaired Driver Projects conducted at various locations in the Waimea District in attempts to reduce the number of traffic collisions due to intoxicated drivers.
- Officer's participated/volunteered their time in "Shop with a Cop" program at Kmart.
- Conducted speed enforcement and monitoring at numerous locations in the district where complaints and frequent incidents were reported.
- Assisted DLNR in locating missing hunter vicinity of the Milolii area in the Kōke'e State park
- Assisted Kukuiula Land Trust with posting illegal campers on private property vicinity of the Waimea Pier.
- Assisted with the evacuation drill at Waimea High School
- Conducted a special project "Inner Circle Legal Service" where officers went and served arrest warrants.

INVESTIGATIVE SERVICES BUREAU (ISB)

The Investigative Services Bureau is responsible for investigating all felony offenses that are referred by the Patrol Services Bureau and may include more complicated misdemeanor offenses. When appropriate, they initiate their own investigations.

The bureau is divided into three (3) Major sections: General Crimes, Special Focus and Vice.

The bureau support sections includes: Crime Scene Specialists (CSS), Domestic Violence Intervention Coordinator (DVIC) and Sexual Assault Nurse Examiner (SANE) Program.

The General Crimes Section primarily conducts investigations associated with crimes against persons.

The Special Focus Section primarily conducts investigations associated with crimes against property.

The Vice Section is responsible for investigating and enforcing all laws related to illegal drug activity.

A. Program Objectives - Investigative Services Bureau (ISB):

Bureau investigators are responsible for the preparation of arrest and search warrants, apprehending perpetrators, gathering and preserving evidence, conduct interviews and preparing their respective cases for prosecution.

The Bureau conducted community outreach through informational presentations and is supported by personnel from other Bureaus. Presentations included drug awareness resistance education and theft and burglary prevention in an effort to minimize victimization.

A standby-detective program is in place to ensure an immediate response for after-hour investigations involving major felony offenses and incidents of specific interest.

The Vice Section conducts investigations of drug offenses at local, state and federal levels. The Vice Section strives to increase the number of drug investigations conducted in an effort to curtail the use, sale, and distribution of illegal narcotics and drugs.

B. Program Highlights - Investigative Services Bureau (ISB):

General Crimes Section

Major Cases

Murder

Detectives responded to a reported stabbing that occurred at a First Hawaiian Bank Lihue. Upon arrival, it was learned that the victim was a 68-year-old female resident who was later pronounced as deceased. An autopsy revealed that the nature of the death was a homicide. The suspect was identified as a 34-year-old male resident who was related to the victim. The suspect was arrested and held on \$1,000,000.00. (May 2018)

Detectives responded to a 67 year old female was found deceased in her residence located in Omao. Detectives initiated a homicide investigation based on initial observations. An autopsy was performed on the deceased and the nature of the death was confirmed to be a homicide. The investigation revealed that the suspect was a 61-year-old male who was the tenant of the deceased. The suspect was placed under arrest for Murder 2nd and held on \$1,000,000.00 bail. (June 2018)

Kidnapping

Detectives conducted an investigation regarding a 37-year-old female reported to have been held against her will and sexually assaulted by her estranged 38-year-old boyfriend. The female was treated for injuries at the hospital and a KPD SANE nurse conducted SANE exam. The suspect was located and arrested a few days later for violating a temporary restraining order involving the same victim. (January 2018)

Sexual Assault

Detectives conducted forensics interviews with three juvenile females at the Children's Justice Center of Kauai. The three female juveniles disclosed being sexually assaulted by a family member, who was also a male juvenile. The suspected male juvenile was questioned regarding the allegations and admitted to sexually assaulting the three female juvenile victims. The suspect was subsequently arrested for multiple counts of sex assault and because he was a minor, he was released to his guardian. (July 2017)

Detectives investigated a report of a 16 year old female being sexually assaulted multiple times from age 5 to 13 by an adult male family member. The report was initiated through the YWCA. The suspect male 65 years old, was questioned by Detectives whereby he admitted to repeatedly sexually abusing the victim. The suspect was arrested for multiple sex related offenses and held on bail for \$50,000.00. (February 2018)

Robbery

Detectives investigated a report of a Robbery in the 2nd degree at the Garden Island Inn Hotel (Nawiliwili) The suspect male 21 employee of Pride of America Cruise Ship attacked another male 33 who is also an employee of the Pride of American Cruise Ship while in the suspects' hotel room. Victim escaped from the room, suspect chased down the victim as the victim attempted to run to the ship. Suspect assaulted the victim on Nawiliwili Rd near mile marker

0. Suspect forcibly obtained the victim's wallet and fled the scene. Suspect was located and arrested. (October 2017)

Promoting Child Abuse

The Detective of the Hawaii ICAC Task Force was alerted that a video containing suspected child pornography was downloaded to an IP address located on Kauai. Detectives prepared and served search warrants on various communication companies to identify the perpetrator and the exact address in which the pornography was downloaded.

Upon identifying the perpetrator and address of the download, Detectives prepared a search warrant to search the perpetrators residence for child pornography. On February 27, 2018, Detectives executed the search warrant and seized various computers, cellular telephones and tablets.

A 33-year-old male resident was arrested and confessed to downloading various child pornography over the past year. The suspect was booked and released pending investigation. The FBI was contacted and will be assisting in analyzing the recovered evidence. (February 2018)

Death Related Report

Detectives conducted an investigation into, two local males that were scuba diving along the south shore of Kauai. While approximately 25 yards from the shoreline they were caught in a strong current. One of the males began to panic and removed his respirator. The second male along with a bystander were able to bring the distressed diver to shore. Medics responded and transported him to Wilcox E.R. where he was pronounced as deceased. It was learned that the deceased, a 33 year old male, had no scuba diving experience. An initial inspection of his diving gear showed that it was in working order. An autopsy was conducted and the preliminary cause of death was ruled as a drowning. (May 2018).

Search Warrants

In fiscal year 2018, General Crimes Detectives initiated and executed 51 search warrants on homes, vehicles, persons, bags, backpacks, cell phones, and social media accounts from all ten districts on Kaua'i. Numerous items related to evidence of a homicide, attempted homicide, sex assaults, robberies, assaults and other violent crimes were recovered and seized. The recovery of evidence led to numerous arrests and convictions. Some cases are still pending trial.

Special Projects

It has been one year since the Kaua'i Police Department initiated the Lethality Assessment Program (LAP). In partnership with the Hawaii State Coalition Against Domestic Violence,

the LAP Program aims to reduce Intimate Partner Violence (IPV) and the lethality associated with violent relationships. During fiscal year 2018, there were 214 lethality screenings conducted at IPV incidents where 102 were deemed as a high danger of lethality. In those cases, 91 individuals received assistance from the Young Women's Christian Association (YWCA).

In keeping with the continued efforts regarding the Sexual Assault Kit Initiative (SAKI), House Bill 1907, Act 207, KPD has sent out 111 Sexual Assault Kits for analysis from July 2017 to July 2018. As of July 2018 all Sexual Assault Kit stemming from 2001 have been sent out for analysis to either Honolulu Police Department or Sorenson Forensic Laboratory. In collaboration with the Sexual Assault Kit Initiative, the Kauai Police Department has recently hired and additional three more part time Sex Assault Nurse Examiners. This will assist with the staff coverage for stand by call out shortages.

The Kauai Police Department enhanced their Crime Scene Specialist team by hiring two more Crime Scene Specialist that has decreased the excessive workloads and increased the overall response time. In turn the capabilities of CSS Unit's response package has enhanced the overall technical support in complex investigations relating to trace evidence i.e. DNA collection and analyzation. CSS conducted 66 ParaDNA case samples.

Notable Drug Investigations

The vice section located and arrested a male subject who had an outstanding bench warrant totaling \$200,000. A canine sniff was conducted on the vehicle the male subject was located which resulted in an alert. A search warrant was obtained and within the vehicle was 30.2 grams of Crystal Methamphetamine, 29.2 grams of processed marijuana, 3.5 grams of Heroin, four(4) pills identified as Tramadol Hydrochloride a Schedule IV drug, five(5) pills identified as Burprenorine a Schedule III drug, eleven(11) pills identified as

Zolpidem a Schedule IV drug, one(1) pill identified as Diazepam a Schedule IV drug, one(1) pill identified as Morphine a Schedule II drug, one(1) pill identified as Hydrocodone a Schedule II type drug and \$150.00 US Currency.

Members of the Vice Section along with the Kauai Police Department's Special Response Team executed a Search Warrant on a male suspect at a Hanalei district residence. The suspect and four other occupants of the residence were located and arrested. A search of the residence recovered a loaded .22 caliber rifle, approximately .7 grams of crystal methamphetamine, 1013.3 grams of processed marijuana, 14 outdoor marijuana plants, various drug paraphernalia, and U.S. currency totaling approximately \$1634.00. Suspects located in the residence were arrested for various drug and firearm charges.

The Vice Section initiated a traffic stop of a vehicle. The driver was arrested on a \$50,000 drug warrant. A canine screening was conducted and the K9 alerted to the odor of narcotics coming from within the vehicle. Based on the investigation, a Search Warrant for the vehicle was reviewed and granted. As a result of the search warrant, approximately 453 grams of methamphetamine, 400 grams of black tar heroin, and approximately 62 grams of marijuana. Also recovered was a Zip Loc type bag containing approximately 23 grams of a white powdery substance that tested positive for Fentanyl. Also recovered was approximately \$32,000 in U.S. Currency. It's estimated that the heroin had a street value of \$65,000 and the methamphetamine had a street value of \$20,000.

The Vice Section Officers along with the DEA Hawaii Task Force conducted a joint investigation on information obtained by KPD that a UPS parcel was being shipped to a known target on Kauai. KPD located the UPS parcel at the Lihue Airport sort facility with a positive canine alert on the parcel. A Federal Search Warrant was obtained and executed on the parcel. Located within the parcel was 1000.2 grams of Crystal Methamphetamine. Control delivery was conducted with a Tim Jimenez accepting the parcel and later transported to the Federal Detention Center on Oahu.

The Vice Section Officers along with DEA Hawaii Task Force conducted a joint investigation on information obtained by KPD that a FedEx parcel was being shipped to a known target on Kauai. DEA Airport task force located the FedEx parcel on Oahu with a positive canine alert. A Federal Search Warrant was obtained and executed on the parcel. Located within the parcel was 992.2 grams of Crystal Methamphetamine. Control delivery was conducted with the parcel not opened.

The Vice Section with the assistance of DLNR, conducted an operation to locate and arrest a male subject for an outstanding Revocation Modification warrant totaling \$50,000. Intelligence was gathered indicated that the subject was in possession of a .22 caliber rifle. Reconnaissance was conducted and the subject was located and arrested without incident. A second team closer to the campsite made contact with a second subject with \$37,000 in warrants was located attempting to flee from the scene. While at the location, Officers located 33 marijuana plants. Charges for the male subject include Commercial Promotion of Marijuana in the 1st degree, two counts Pro Dang Drugs 3rd, three counts of Drug

Paraphernalia, Prohibited Possession, and Place to Keep Firearm/Ammunition. The other party had recommended charges to include Commercial Promotion of Marijuana in the 1st degree, Pro Dang Drugs 3rd, two counts of Drug Paraphernalia, and Place to Keep Firearm.

Vice Section conducted an operation to locate and arrest subjects with arrest warrants who were associated with drug dealing in the area known as “Baby Beach” in the Kawaihau District. During the operation, a subject was arrested on five criminal contempt of court bench warrants totaling \$10,000 for various underlying charges including drugs. Another subject in the area was arrested on two bench warrants totaling \$1,500.

Vice Section conducted a joint operation with the United States Postal Inspector to conduct United States Postal Sweeps at a facility. Federal search warrants were obtained and a total of 1,218.9 grams of crystal methamphetamine, 196.3 grams of processed marijuana, 1,034.0 grams of cocaine and 701.14 grams of marijuana concentrate was recovered.

Vice Section conducted a follow up investigation into a storage locker at the Self-Storage. As a result of that investigation, a search warrant obtained and executed. Located within the storage unit was 44.9 grams of processed marijuana and .1 grams of crystal methamphetamine.

As a participating member of these task forces, the Vice Section has participated in numerous Marijuana Eradication Missions throughout the State of Hawaii and joint multijurisdictional investigations and arrests.

Public Relations | Community Service

- Assisted with the Citizens Police Academy with a presentation for the Vice Section.
- Conducted a baseball clinic with major league baseball alumni for kids aged 5-14 at the Lihue Baseball Park
- Assisted a youth football camp for the REP50 for kids aged 6-13 and 14-18 at the Kapa`a Sports Complex.
- Participated with events at the Koloa Plantation Days event in Koloa
- Assisted with the Relay for Life event at Hanalei park
- Participated in the Reece Toyama Baseball Clinic on Oahu at the University of Hawaii Baseball Stadium for youths ages 7-17.
- Participated as the Keynote speaker at the Koloa Elementary School 140th Anniversary Christmas Celebration.

Special Focus Section

Major Cases

Assault

An adult female was arrested in the Kawaihau District on the strength of an Informational Charging Warrant for the offenses of Assault in the Second Degree, Endangering the Welfare of a Minor, and Reckless Driving. The suspect is no longer incarcerated awaiting judiciary proceedings. (July 2017)

Burglary

An adult male suspect was arrested in the Koloa District for Burglary in the Second Degree. Based on the preliminary investigation, information was obtained that the suspect was in possession of thousands of dollars of stolen items in his rented storage bin/garage. The Detective conducted a total of three (3) search warrants, and recovered the majority of the reported stolen items in the suspect's storage bin/garage. The suspect was arrested and remains incarcerated at the Kauai Community Correctional center. (July 2017)

An adult male was arrested in the Kawaihau District for Burglary in the First Degree, Unauthorized Entry Into a Motor Vehicle in the First Degree, and Unauthorized Control of a Propelled Vehicle. The Detective advised the suspect of his constitutional rights and questioned the suspect regarding the above-mentioned crimes. The suspect denied the allegations and was subsequently booked regarding the crimes. The suspect is currently incarcerated at the Kauai Community Correctional Center. (August 2017)

An adult male was arrested in the Kawaihau District for Burglary in the First Degree. The suspect was located, and a Detective advised the suspect of his constitutional rights and questioned the suspect regarding the above-mentioned crime. The suspect confessed to the allegations and was subsequently booked. A search warrant was executed on the suspect's vehicle, and several of the items stolen from the residence were located in the suspect's vehicle. The suspect is currently incarcerated at the Kauai Community Correctional Center. (September 2017)

Two adult males were arrested in the Waimea District for Burglary in the First Degree. The suspects were located by the Patrol Services Bureau, and subsequently advised of their constitutional rights and questioned by a Detective. The suspects admitted being in the residence, but claimed they had permission to be in the residence. Both suspects were arrested and booked. One suspect was released on bail, and the other suspect was released pending further investigation on the advice of the Office of the Prosecuting Attorney. (September 2017)

An adult male was arrested in the Kawaihau District for Burglary in the Second Degree. The suspect was located, and a Detective advised the suspect of his constitutional rights and

questioned the suspect regarding the above-mentioned crime. The suspect confessed to the allegations and was subsequently booked. A search near the scene resulted in the recovery of the stolen property. The suspect is currently incarcerated at the Kauai Community Correctional Center in lieu of \$10,000 bail. (October 2017)

An adult male was arrested in the Koloa District for several felony charges to include Burglary in the First Degree, Sexual Assault in the First Degree, and Kidnapping. The suspect was advised of his constitutional rights, and elected to make a statement. The suspect admitted to several felony charges, and is currently incarcerated at the Kauai Community Correction Center awaiting trial. (December 2017)

Drug

An adult male subject was arrested in the Kawaihau District for Promoting a Dangerous Drug in the Third Degree (x2), and Promoting a Detrimental Drug in the Third Degree. A Special Focus Detective observed a suspicious vehicle, with a lone occupant exhibiting strange behavior within the vehicle. Based on the Detectives keen observations, it appeared that the suspect was engaging in or in the process of engaging in consuming illegal narcotics. The Detective advised the suspect of his constitutional rights and questioned him regarding the incident. The Detective was able to obtain a confession from the suspect, and the suspect stated that there was heroin, marijuana, methamphetamine residue, and drug paraphernalia in the vehicle. The vehicle was seized, and a search warrant was executed. Heroin, marijuana, methamphetamine residue, and drug paraphernalia was recovered from the vehicle. The suspect was arrested, and released pending further investigation. (March 2018)

Extortion

An adult male was arrested in the Hanalei District for Extortion in the First Degree, Robbery in the Second Degree and Terroristic Threatening in the Second Degree. The suspect allegedly promised individuals who were trapped on the North Shore of the island due to the massive floods and landslides, a ride in his boat to a safe location. Once the individuals boarded the vessel and began to travel on the ocean, the boat captain and crew demanded money, or they would make the boat passengers swim back to the shoreline. The suspect was arrested, and his boat was seized as evidence. The suspect was released pending further investigation. (April 2018)

A Special Focus Detective arrested a juvenile male subject for Theft in the Third Degree and Extortion in the Kawaihau District. The case is in regards to stolen property that was stolen in the Kawaihau District. Through the Detectives investigation, he discovered who the suspect was, and posed as the victim to purchase the stolen property back. The suspect arrived at the pre-determined location and attempted to sale the items back to who he perceived was the alleged victim. The suspect was arrested without incident, and released back to his parent. The stolen item was returned to the owner. (June 2018)

Forgery

An adult male was arrested in the Lihue District on a criminal warrant for (23) twenty-three charges to include Forgery in the Second Degree, Unauthorized Entry Into a Motor Vehicle, Theft of a Credit Card, Fraudulent Use of a Credit Card, and multiple Theft charges. The suspect is currently incarcerated at Kauai Community Correctional Center. (November 2017)

Fraud Use of Credit Card

An adult female was arrested in the Lihue District for Theft in the Third Degree, Forgery in the First Degree, and Fraudulent use of a Credit Card. The Detective advised the suspect of her constitutional rights and questioned the suspect regarding the above-mentioned crimes. The suspect denied the allegations and was subsequently booked regarding the crimes. The suspect is currently incarcerated at the Kauai Community Correctional Center. (August 2017)

An adult male and female were arrested in the Waimea District for the offense of Fraudulent Use of a Credit card. The victim in this case reported her bag was stolen containing her credit cards. The investigation revealed that both suspects used the victim's credit card to purchase items from a retail establishment in the Lihue District. The suspects were advised of their constitutional rights, and refused to make a statement. The suspects were arrested, and later released on bail. (December 2017)

An adult male and female were arrested in the Waimea District for Fraudulent Use of a Credit Card. This incident stems from an Unauthorized Entry Into a Motor Vehicle in which the victim's purse was stolen. The suspects were apprehended after using the stolen credit card to purchase items at a retail establishment in the Lihue District. Surveillance footage captured the crime and was instrumental in the arrest of the two suspects. Both suspects refused to provide a statement. The female suspect was subsequently charged with the offense of Unauthorized Entry Into a Motor vehicle. Both suspects were released on bail. (January 2018)

Sex Assault

A Detective participated in a two (2) day Sex Offender Registry Compliance Project with the US Marshall Service in which seventeen (17) sex offenders were contacted and found to be in compliance. (July 2017)

An adult male was extradited from the San Diego's Sheriff's Department in the state of California to Kauai, and arrested for the Offense of Sexual Assault in the Third Degree. The suspect is currently incarcerated at the Kauai Community Correctional Center. (February 2018)

A Special Focus Detective conducted a Sexual Assault investigation regarding a seventeen-year-old female that occurred in the Kawaihau District. The victim was transported to the Children's Justice Center and a forensic interview was conducted. The victim does not know

the identity of the suspect. A SANE exam was conducted on the victim. At this time, the identity of the suspect is unknown, and the investigation is on-going. (June 2018)

Terroristic Threatening

An adult male subject was arrested in the Waimea District for Terroristic Threatening in the Second Degree, Promoting a Dangerous Drug in the Third Degree, and Theft in the Fourth Degree. The initial incident was a theft at a grocery store that escalated to a terroristic threatening complaint. The male suspect was wanted for questioning for other felony cases. A Detective advised the suspect of his constitutional rights and questioned him regarding the incidents. The suspect refused to provide a statement and was subsequently arrested. The suspect is currently incarcerated at the Kauai Community Correctional Center. (March 2018)

Theft

An adult female suspect was arrested in the Lihue District for Theft in the Second Degree. The Detective advised the suspect of her constitutional rights and questioned her regarding the theft. The suspect admitted to stealing several thousand dollars from her employer over a two month span. The suspect was arrested and posted bail. Judiciary proceedings are forthcoming. (July 2017)

An adult male was arrested in the Lihue District for Theft in the First Degree, Criminal Contempt of Court, and Failure to Appear. The suspect was not questioned regarding the Theft investigation, and is currently incarcerated at Kauai Community Correctional Center. (August 2017)

An adult male was arrested in the Waimea District for Theft in the First Degree. The suspect was allegedly involved in a verbal altercation with his adult sister, became upset, and allegedly took his sister's black-colored, hard, pistol case containing a pistol without permission. The suspect was subsequently located with the pistol case in plain view within his vehicle. The suspect was advised of his constitutional rights, and elected not to provide a statement. The suspect was arrested. A search warrant was obtained and executed resulting in the recovery of the pistol case, but not the pistol. Based on the totality of circumstances, the suspect was released pending further investigation. (April 2018)

Unauthorized Control of a Propelled Vehicle

An adult male was arrested in the Lihue District for Unauthorized Control of a Propelled Vehicle (UCPV) and Promoting a Dangerous Drug in the Third Degree. The suspect stole a vehicle from a car dealership, and the vehicle and suspect were subsequently located. Detectives advised the suspect of his constitutional rights and questioned him regarding the incident. The suspect made an incoherent statement, but denied the allegations. The suspect was currently incarcerated at the Kauai Community Correctional Center, but released shortly after pending upcoming judicial proceedings. (March 2018)

A Special Focus Detective assisted in the arrest of an adult male suspect in the Lihue District for Unauthorized Control of a Propelled Vehicle. The suspect is alleged to have left his personal belongings in the vehicle at the time of the vehicle seizure. The investigating Detective prepared and executed search warrants on the backpacks in question and recovered Oxycodone, Methamphetamine, Heroin, Marijuana, and associated drug paraphernalia. The suspect is currently at Kauai Community Correctional Center. (June 2018)

ADMINISTRATIVE AND TECHNICAL BUREAU (ATB)

The Administrative and Technical Bureau is responsible for training, equipment, recruitment and provides support services to other police bureaus within the department.

The bureau is divided into two (2) main sections: Training Section and Research & Development.

The bureaus support sections include Fiscal/Personnel Section, Records Section, Fleet Coordinator, Abandoned/Derelict Vehicle Coordinator, School Resource Officer Unit, and Background Investigation Unit & Community Relations.

The Training Section is responsible for planning and coordinating training for both sworn and civilian personnel.

The Research and Development Section is responsible for procuring uniforms and equipment, assisting with department inventory and recruitment and hiring.

A. Program Objectives – Administrative and Technical Bureau (ATB):

Effectively maintain and manage the following; police records, information systems, fingerprinting and photographic services, evidence storage, documentation regarding service of warrants and legal documents, issuance of permits and registration of firearms.

Assist in the development of efficient and professional police personnel by developing and coordinating training programs including; recruit training, in service training, emergency vehicle operations, self- defense, firearms, forensics, sexual harassment and supervisory training.

Continue to seek potential funding for the department via Federal and State Grants.
Recruit, screen, and hire suitable and qualified personnel to fill vacancies within the department.

ATB is responsible for ordering, maintaining and distributing equipment. As well as negotiating, procuring and managing a variety of KPD contracts.

B. Program Highlights - Administrative and Technical Bureau (ATB):

Research and Development Section

The Kaua'i Police Department's 90th recruit class academy officially starts in September 2018. The stats from July 2017 – April 2018 are as follows: 393 individuals applied, Ninety two (92) showed for the written exam, sixty three (63) passed and were processed by ATB staff members. On June 1, 2018, 5 police recruits started their careers with the department. After being trained by members of the bureau's training section, they were assigned to work in cellblock prior to starting the police academy. This continued practice of assigning newly hired recruits into cellblock has reduced the number of days off cancelled patrol personnel and has reduced overtime expenditures which saved the County of Kaua'i in overtime costs. It has also provided the new recruits with on the job experience. On August 16, 2018, 3 more police recruits will be joining their classmates. All eight police recruits will be assigned to training for approximately twenty eight (28) weeks for the classroom portion of the academy. Staff members of ATB are currently recruiting for the 91st Police Recruit Class with continued testing monthly.

The Kaua'i Police Department has also been busy with filling civilian positions to include Emergency Services Dispatcher, SANE Nurse, Counter Drug Analyst and a new position in Patrol Services, an Administrative Support Assistant. Since last year's report was completed, twenty three (23) individuals applied for an emergency services dispatcher position. Seven (7) showed for the written tests, six (6) have withdrawn and one (1) is pending their background investigation. Two (2) SANE Nurses applied and both were hired. One (1) individual was referred for the Counter Drug Analyst position and was hired. For the Administrative Support Assistant position, seventeen (17) names were referred and twelve (12) have withdrawn. Five (5) candidates have been cleared through extensive background investigations and are pending interviews with members from the Patrol Services Bureau.

ATB Staff members have also completed approximately forty-three (43) background investigations for individuals who work for outside agencies that needed to gain access into the Kauai Police Department's facilities for work related duties.

Training Section

The Training Section is committed to remaining at the forefront of all aspects of law enforcement training. The goal is to ensure that training is relevant, sound and appropriate to the community we serve.

The Training Section provides recruit training, in-service training, specialized training and in select cases, training to civilians.

Grant Projects FY2018

The Project Manager in each program is responsible for acquiring State and Federal grant revenue funds. Most grants extend over multiple years. The Administrative and Technical Bureau is accountable for the fiscal reporting and tracking of the following grant awards. The following are grants managed during the fiscal year.

1. State Highways Special Enforcement (State DOT - \$539,295):
Law enforcement and public education relating to distracted driving; deter drivers from drinking and driving, enforce underage drinking, enforce seatbelt and speeding laws and provide training for Traffic Safety Unit officers.
2. 911 Emergency Medical Services (State Department of Health - \$179,900):
To operate a central 911 and dispatch communications center for emergency medical ambulance service.
3. Statewide Multijurisdictional Drug Task Force (State Attorney General - \$46,375):
To eradicate marijuana and prohibit drugs in the State by counteracting smuggling of narcotics via apprehension and conviction in Hawaii through a multi-agency/multi-jurisdictional cooperative effort.
4. Domestic Cannabis Eradication/Suppression Program (U.S. Department of Justice- \$50,000):
To eradicate illegal cultivation of marijuana.
5. High Intensity Drug Trafficking Area HI-IMPACT (Office of National Drug Control Policy - \$301,517):
To combat the drug problem, specifically that of Crystal Methamphetamine.
6. State Law Prohibiting Tobacco Sales to Minors (Department of Health - \$10,000):
To reduce tobacco sales to minors.
7. SANE Recruitment, Training, Standby & Exams (State Attorney General - \$48,462):
To strengthen County of Kaua'i response to adolescent and adult female victims of sexual assault by recruiting, training and retaining new SANEs (Sexual Assault Nurse Examiners), and by providing continuing educations to current SANEs and sex crimes investigators. Also to provide SANE exams to all adolescent and adult female victims of sexual assault according to the statewide examination criteria developed and adopted by members of HSART (Hawaii Sexual Assault Response Team), and to analyze forensic evidence to assist in the investigation.
8. COPS Hiring Program Grant (Department of Justice - \$750,000):
Increase the number of first responders by six (6) officers for the Kaua'i Police the Department to allow a more even distribution of caseloads among officers while promoting community policing strategies aimed to prevent, solve and control crime.
9. Bulletproof Vest Partnership (Department of Justice - \$4,128):
Reimburse Kaua'i Police Department 50% of the cost of replacement bulletproof vests for safety of the officers.

10. BJA Firearms Grant Program (Hawaii Criminal Justice Data Center/JAG - \$35,100):
Reimburse Kaua'i Police Department for labor and equipment to improve the completeness of firearms background checks through enhanced data sharing.

Enhanced 911 Fund

The Enhanced 911 Fund was established in accordance with Act 159/SLH 2004, as a special fund outside of the state treasury, to be administered by the Enhanced 911 Board. The fund consists of monthly surcharge collections imposed on each Commercial Mobile Radio Service (CMRS) connection (wireless telephones and similar devices). The Administrative & Technical Bureau's Assistant Chief represents the County of Kaua'i at the State of Hawai'i Enhanced-911 Board meeting and Technical and Finance Committee meetings each month. The ATB Bureau is also responsible for the submittal of reimbursement requests to the Enhanced 911 Board for corresponding expenditures detailed below.

1. Akimeka, LLC. – \$423,760:
Provides continued Wireless Enhanced 9-1-1 (E9-1-1) Program Management and Geographic Information System (GIS) Services for Neighbor Island Counties to support on-going operations and maintenance of their E9-1-1 system
2. Hawaiian Telcom - \$358,353:
Hawaiian Telcom Intrastate Tariff Charges charged for each Cache Meta Language (CML) position housed in a Public Safety Answering Point (PSAP) and the Alternate Dispatch Center (ADC) is reimbursed by the Wireless Enhanced Board Funds. This service through Hawaiian Telcom is necessary in order to receive emergency 911 calls. The Hawaiian Telcom trunk charges are the only mechanism for the PSAPs to receive emergency 911 calls. Without this service, none of the emergency responders would be able to respond to emergency 911 calls.
3. Computer Aided Dispatch (CAD) Maintenance \$845,010:
Funding is to reimburse for the multi-term support agreement that covers annual maintenance to upkeep, upgrade and continually maintain the software in the Public Safety Answering Point (PSAP). The maintenance and support program for the County of Kauai is mandatory to ensure the integrity of our system. It also integrates our Public Safety Software System which includes but is not limited to Computer Aided Dispatch (CAD), Records Management System (RMS), Integrated Hub, Mobile, Geographic Information System (GIS) interfaced with current Pictometry and MSAG provided by Akimeka, multiple modules and interfaces, training, implementation and maintenance.
4. Public Safety Answering Point (PSAP) Furniture Replacement \$49,000:
County of Kaua'i PSAP serves first responders that belong to Police, Fire and Ambulance Response for the entire island. The PSAP furniture and monitors were the original equipment since the build of the Kauai Police Department in 2002.

5. Travel - \$27,500:

Provides funding for County of Kaua'i representatives to travel to attend the monthly board meetings and annual training conference, which is reimbursed by the Wireless Enhanced Board funds.
