II. DEPARTMENT/DIVISION GOALS

All goals herein are for calendar year 2014. The results will be reported in the Kauai Police Department Annual Report.

Overall Kaua'i Police Department (KPD) Goals:

1. We will continue to focus on our recruitment efforts on hiring Police Services Officers with emphasis on increasing gender ratios with the goal of hiring 3 or more qualified female officers.
2. Community outreach to engage and empower our citizens is vitally important to reduce the feelings of fear and helplessness. We will do this by assuring them that crime is not out of control and dispel negative media reporting that distorts the fact that Kauai is the safest county in the State. In that regard, a minimum of 5 meetings shall be held to address victimization and security concerns, especially with our aging population.
3. The use and trafficking of illicit drugs has far reaching negative influences on our communities. Many of the most violent crimes have a nexus with illegal drugs: domestic violence, murders, assaults, and crimes against property such as burglaries and thefts. The Kauai Police Department understands the connection related to drug purveyors and our quality of life and is therefore committed to apprehend, disrupt, and dismantle at least 2 or more major Drug Trafficking Organizations operating within this jurisdiction.
4. Traffic studies reveal that crashes nationwide account for almost \$3 billion in losses because of medical and emergency services, lost earning and household production, property damage, and lost quality of life. Annually 33,000-40,000 people die on our nation's roadways. As such the National Highway Traffic and Safety Administration urges policymakers at all levels of government to make traffic safety a top priority.

For the past 6 years, Kauai has recorded 45 crashes resulting in 50 fatalities. But, because traffic safety is a continuing priority with this administration, there is still cause to be optimistic as Kauai has the lowest number of traffic related fatalities of the four counties, by far. In keeping with this commitment there will be a concerted effort to reduce by 5 percent the total number of serious traffic crashes when measured against 2013. The strategic plan to decrease serious crashes will include greater enforcement efforts relating adverse driver's behaviors such as speeding, driving under the influence, reckless and distracted driving, and seatbelt and child restraints

Patrol Services Bureau (PSB) Goals:

1. The Next Generation 911 communication system has been deployed statewide by Hawaiian Tel and Intrado. The system was upgraded from an analog system to an IP based network. This allows the ability for 911 callers to send text messages, photos, and

videos. The first phase will be text messaging that the 911 Dispatchers will receive through the Intrado Viper system. It is anticipated that texting to 911 will be available soon, followed by photos and videos. Each 911 center must develop an interface to allow the Viper information, (text, photo, video) to be transferred into their CAD system. This will allow the flow of information to mobile data terminals, Records management, and other systems that require the 911 data.

2. Traffic enforcement and education remains a key component of our efforts to reduce traffic fatalities and serious vehicle collisions. Within the past fiscal year, KPD has issued 21,385 citations with almost 257 driving impaired arrests.
3. Critical issues concerning outstanding felony bench warrants are also being addressed with the use of a special mobilized unit within KPD, whose greater focus is suspects who are the most dangerous to our community.

Investigative Services Bureau (ISB) Goals:

1. Narcotics/Vice Section Goals:
It is the goal of the Vice Section to disrupt current narcotics/vice activities and to prevent future development of organized crime in the County of Kauai, State of Hawaii through public awareness and education, interdiction and eradication, and through continued long-term and complex investigations leading to the arrest and prosecution of all parties involved.
2. Conduct at least five (5) undercover sting operations targeting illegal sales of tobacco to minors and underage drinking.
3. Provide at least ten (10) in-service informational briefings with Patrol Services Bureau.
4. Plan, coordinate and direct community youth sporting events for youth throughout the island.
5. Increase the number of certified Sexual Assault Nurse Examiners from three to four SANEs.
6. Participate in bi-weekly meetings with the Office of the Prosecuting Attorney (OPA) to review and discuss cold-case files, and all other investigations and procedural items of concern or interest.
7. Establish specific and specialized units within the detective section, separating crimes against person from property crimes, allowing the detective to be trained and experienced in a specific discipline to focus on specific type of crime

8. Increase the number of trained detectives as Forensic Interviewers who are able to conduct both child abuse and child sexual abuse specialty investigations.
9. Continue to improve the working relationship between the County Public Information Officer, and with the media to provide the community information related to crime trends, reporting of suspicious persons/activities, and personal and property safety and security; avoid becoming a victim of crime.

Administrative and Technical Bureau (ATB) Goals:

1. Start two recruit classes of PSO's within the year by streamlining the recruitment and hiring process.
2. Roll-out and installation of Mobile Data Terminals in Patrol vehicles and selected unmarked vehicles.
3. Migration and implementation of VisionAir Mobile, Field Base Reporting (FBR), and the new VisionRMS (Records Management System).

Office of Professional Standards* (OPS) Goals (FY 2014):

1. CALEA** certification by the end of Fiscal Year 2015.
2. Conduct at least 3 quality control and compliance inspections a quarter in all of the Bureaus of the Kauai Police Department.
3. Conduct at least 1 training a quarter in the proper way to intake a citizens' complaint against a KPD employee.
4. Conduct at least 1 training a quarter on the proper use of the Blue Team System.
5. Increase the number of OPS Investigators from 1 to 2 by the end of Fiscal Year 2016.

The Police Commission consists of seven members who are appointed by the Mayor and confirmed by the County Council. The Commission adopts rules as it may consider for the conduct of its business and regulations of matters relating to the goals and aims of the department. (Article XI 11.03.A)

Appointments are for a three year term with a maximum of two terms.

The Police Commission receives, considers and investigates charges brought by the public against the conduct of the department or any of its members. The Commission is also responsible for reviewing the annual budget. (Article XI 11.03.B/C)

The Police Commission received forty-one (41) notarized complaints during the fiscal year. There were twenty-five (25) that were found insufficient, and six (6) were found sufficient; five (5) complaints were found not within Commissions jurisdiction; one (1) complaint exceeded the timeframe for filing a complaint; and four (4) complaints are still pending.

The Police Commission held twelve (12) Regular Sessions, twelve (12) Executive Sessions and one (1) Special Executive Session Meetings during FY 2014.

Office of the Chief of Police

The Chief of Police is responsible for the preservation of the public peace, protection of the rights of persons and property, prevention of crime, detection and arrest of offenders, and enforcement of all laws of the State and County ordinances and all rules and regulations made pursuant thereto.

The Chief of Police is responsible to equip, train, maintain and supervise a force of police officers and civilian staff. The Chief is also responsible for the serving of processes and notices both in criminal and civil proceedings.

The Chief of Police plans, organizes staffs, directs and controls the personnel and resources of the department, and administers the department in a manner consistent with the Charter of the County of Kauai and the laws of the State of Hawaii.

The Chief of Police shall make such reports from time to time as the Police Commission shall require, and shall annually make a report to the Commission of the state of affairs and condition of the department.

The Office of the Chief of Police provides overall direction and supervision to all of the sub-units and personnel of the department. It establishes departmental goals and priorities and monitors the progress of bureaus in attaining these goals. It also directs and supervises the information gathering and enforcement efforts of the Criminal Intelligence Unit (C.I.U.). The Criminal Intelligence Unit also includes an Internal Affairs Unit which investigates complaints against police officers.

Patrol Services Bureau (PSB)

The Patrol Services Bureau is responsible for the preservation of the public peace, prevention of crimes, and pursuit of offenders, enforcement of State laws and County ordinances, and protection of rights.

Investigative Services Bureau (ISB)

The Investigative Services Bureau is comprised of three (3) sections: The General Crimes Section, the Special Focus Section, and the Vice Section.

The General Crimes Section conducts complex and detailed investigations of criminal cases and certain non-criminal cases, which may be associated with death reports and other unique situations which require further examination. Investigations primarily focus on felony offenses, but may include more complicated misdemeanor offenses.

The Special Focus Section includes investigations into white-collar/financial crimes, computer crimes, domestic violence cases, missing persons cases, and the School Resource Officers (SRO) program.

The SRO's are assigned to the 3 high schools (Kapaa High, Kauai High and Waimea High). The SROs participate in, and is an instructor in school-related programs such as DARE (Drug Abuse Resistance Education) and Keepin' it Real, which is an Evidence Based Drug/Crime Prevention Education Program. Instructions are provided to 7th graders at all three middle schools and to 5th graders in all elementary schools across the island; offering counseling and mediation services within the respective school and investigate school-related incidents. The SRO conducts investigations into school related incidents, assist with emergency planning and participate with drills and exercises related to student and faculty safety and security..

The SRO program also administers the K-PAL program, which plan, coordinate and direct after-school and weekend activities for youth ranging in grades Kindergarten thru 12th grade.

The Vice Section conducts complex investigations into drug/narcotic offenses on local, state and federal levels.

Administrative and Technical Bureau (ATB)

The Administrative and Technical Bureau provides support services to other police elements within the department, as part of a concerted effort to assist them in attaining their goals and objectives. Equally significant are bureau services that are provided directly to the public, especially via the Records and Community Relations sections.

Operational facets include overseeing the department's budget of over 26 million dollars, maintaining payroll, and keeping pace with personnel, human relations, and workplace environment issues. The Training section coordinates all official department training, including the police academy for newly hired recruits.

Recruitment and retention of personnel, especially sworn police officers, remains a high priority for the department, with the Training, Research & Development, and Personnel Sections taking lead roles in addressing this critical area.

A. OBJECTIVES

Program Objectives – Overall Kaua'i Police Department:

To enhance and institutionalize the philosophy of Community Policing and the creation of a positive and pro-active partnership between police officers and our citizens; to be responsive to the needs of our community.

To increase positive interactions and programs with and for the youth of our community to reduce the probability of youth crimes.

To develop and promote an internal work environment based on mutual respect, dignity, and trust; to ensure that all employees are treated fairly and equitably.

To provide efficient and aggressive law enforcement so as to prevent criminal behavior, and to apprehend those responsible for criminal acts.

To aggressively pursue and obtain the resources, training, and equipment needed by our employees to maximize their efficiency and effectiveness.

The Kauai Police Department supports the belief that there is a direct correlation between an increase in drug arrests and seizures, and subsequent decrease in the number of overall crimes. To this extent we remain committed to ensuring that all possible efforts will be taken to reduce drug related elements within the Community.

The amount of new hires, especially police officers, continues to be a reflection of the positive strides being made in this area. However, keeping pace with retirement and other attrition factors have been and will remain a challenge in FY 2015.

Program Objectives - Patrol Services Bureau (PSB):

Increase emphasis on driver education and awareness, voluntary compliance with traffic ordinances and statutes, injury prevention and enforcement of hazardous moving violations (traffic safety).

Continue training and awareness for patrol personnel, including Incident Command System, man-made and natural disaster hazard mitigation.

Continue to pursue the planning and construction of the Kawaihau Sub-station for the community.

Progress has been made in regards to implementing another beat in the Kawaihau District. Plans are being finalized to implement this before the end of CY 2015.

To procure communication and other support equipment via the Homeland Security Grant(s) for continuity of operations during emergency events, whether natural or manmade.

Continue to promote positive interaction between the public and police officers, with the goal of addressing and mitigating public safety issues and concerns. This includes participation and attendance at community/neighborhood meetings; volunteering at special events/non-profit fundraisers; appearing at schools; and participating in youth programs.

Program Objectives - Investigative Services Bureau (ISB):

Bureau investigators are responsible for the preparation of Arrest and Search Warrants, apprehending perpetrators, gathering and preserving evidence, conduct interviews and prepare their respective cases for prosecution.

The Bureau conducts community outreach by conducting informational presentations, which is supported by the personnel of the various disciplines. This includes, but is not limited to, drug and gang awareness resistance education, theft and burglary prevention to minimize victimization.

A standby-detective program is in place to ensure an immediate response for after-hour investigations involving major felony offenses and incidents of specific interest. A detective is on standby status during non-business hours and is available to respond as needed, depending on the severity or complexity of the incident.

The bureau also invests in youth development program such as the K-PAL program. This program, which is active year-round throughout the island, is used as a tool to bring juveniles into safe and supervised activities as well as a common gathering place. The athletic/recreational activities provide valuable lessons in teamwork, self-esteem, discipline, sportsmanship and the merits of hard-work. In turn, this provides venues where K-PAL can provide Evidence Based Crime/Drug-prevention education more effectively.

The vice section seeks to increase the number of drug investigations conducted, leading to search warrants being executed and to affect the arrest of individuals involved in the use, sale and distribution of narcotics, to include marijuana, cocaine, crystal methamphetamine and other illicit drugs.

Program Objectives - Administrative and Technical Bureau (ATB):

Enhance the relationship between the community and police department through community policing projects and programs.

Effectively maintain and manage the following; police records, information systems, fingerprinting and photographic services, evidence storage, service of warrants and legal documents, issuance of permits and registration of firearms.

Assist in the development of efficient and professional police personnel by developing and coordinating training programs including; recruit training, emergency vehicle operations, self-defense, firearms, forensics, sexual harassment and supervisory training.

Research, develop, and circulate department directives, and update existing General Orders.

Continue assessing computer needs for the department to enhance operational efficiency, including the Computer Aided Dispatch (CAD) and Records Management System (RMS) systems.

Continue to seek potential funding for the department via Federal and State Grants.

Recruit, screen, and hire personnel to fill vacancies within the department.

Manage fiscal, personnel and procurement for the Police Department.

B. HIGHLIGHTS

Program Highlights – Overall Kauai Police Department:

KPD has had many successes this past fiscal year. KPD's most important achievement was the hiring and training of nine new police officers who are presently assigned to the Patrol Services Bureau. With the infusion of the new officers into the patrol schedule, overtime expenditures have been reduced in the area of cancelled days off to cover basic services.

Another success and achievement this past fiscal year is the grant award received from the Department of Justice for \$750,000. These funds, along with County matching funds, will allow KPD to expand the number of beats serving Kaua'i from 10 to 11. Beat expansion has not occurred within the police department for over twenty years. The additional beat will allow KPD to provide better services to the community and further our community oriented policing efforts.

Accreditation continues to be a major goal through changes in policies and procedures, training, and internal accountability.

In order to develop a long-term 5-15 year strategic plan, KPD will be procuring the services of experts in this area. This effort will work in conjunction with acquiring additional facilities throughout the island while continuing to focus on beat expansions with additional staffing—officers and civilians alike.

Program Highlights – Patrol Services Bureau (PSB):

Enforcement: The overall number of citations issued by the Patrol Services Bureau increased by approximately 18% from the previous year. There was no significant change in Operating a Vehicle Under the Influence of Intoxicants (OVUII) arrests. An increase occurred in the category of hazardous moving citations, up approximately 21 % from last year. Speeding citations issued increased 37% from previous year. The total number of Seat Belt citations increased 27% from the previous year. The total number of arrests decreased by 26% while the service of warrants increased by 33%.

Traffic Safety Unit personnel directed traffic or closed roads for 21 events which included Hospice Concert in the Sky, Kōloa Plantation Days Parade and the Kaua'i Marathon.

Community Meetings/Presentations/Apearances: Personnel from the Patrol Services Bureau attended and/or conducted numerous presentations for community organizations, school and business related events. As in previous years, there was an effort by line officers and supervisors to attend meetings and functions including the Mayor's community meetings.

Officers taught students at various schools about seatbelt use, bicycle safety, Halloween safety and personal safety awareness. They also participated in Keiki ID projects, parades, and numerous community and non-profit fundraisers. PSB personnel also participated in youth sports programs as coaches, referees, and parent volunteers.

Program Highlights - Investigative Services Bureau (ISB):

SEARCH WARRANTS

From July 1, 2013 to June 30, 2014, Detectives initiated and executed 77 search warrants on houses, vehicles, persons, bags/backpacks, cell phones, and social media accounts from all 10 Districts on Kauai. Numerous items related to evidence of a homicide, justified homicide, thefts, and burglaries were recovered and or seized leading to numerous arrests/convictions as well as some cases still pending trial.

JUSTIFIED USE OF DEADLY FORCE / OFFICER INVOLVED SHOOTING

In August 2013 KPD patrol officers were involved in an officer-involved shooting, having defended themselves against a male suspect who was armed with 2 firearms. This incident occurred in the vicinity of the Nawiliwili seawall. The male suspect died at the scene following the shooting. The officers involved in this incident were placed on administrative leave and returned to work following a review by the Kauai Office of the Prosecuting Attorney.

SPECIAL PROJECTS

Island of Kauai (Pawn Shop Detail)- In August 2013, Detectives conducted Operation Pawn Shop Detail in which any Pawn shop or second hand dealer on Kauai were informed of the mandatory inspection and compliance laws pertaining to HRS 486M-1 (Definitions), 486M-2 (Record of transactions), 486M-3 (Transactions by minors prohibited), 486M-4 (Minimum retention of items), 486M-5 (Inspections), 486M-6 (Applicability), 486M-7 (Penalties), 486M-8 (Severability). This ongoing Pawn Shop Detail was created to help monitor, recover, identify, apprehend and get a grip on the person(s) responsible for the large amounts of stolen jewelry and other precious items stolen from burglaries and thefts being traded in for cash.

From August 2013 to December 2013, as a result of the recently established KPD Pawn Shop Detail, Detectives were able to secure 3 arrest warrants and 2 search warrants leading to the arrest of five individuals for the offenses of theft and burglary. Ongoing Spot checks and follow-ups are being conducted by ISB Detectives to further apprehend and recover items of precious coins, metals and other valuables taken from residential burglaries and theft investigations reported by victims to the Patrol Services Bureau. The Pawn Shop Detail was established for the reasons mentioned above and it is the hope and goal of KPD's investigation section to curb burglaries and thefts on Kauai.

In the first week of October 2013, ISB Detectives (3) conducted a three day undercover surveillance, intelligence gathering and follow-up investigation regarding Burglaries, UEMV's and thefts occurring on the North Shore of Kauai. Detectives met and spoke with the Hanalei District Commander as well as numerous Kapaa and Hanalei supervisors and patrol officers to share information and network on what possible courses of actions could be taken to help reduce the number of property crimes occurring on the North shore as well as identifying the primary suspects involved in these crimes. A suspect was identified and was later arrested following a car break-in at Kee Beach State Park.

MAJOR CASES

From September 2013, the Cybercrimes Detective opened up two Child Pornography investigations that were linked to a single common IP address. Based on the information from the Cyber tool from ICAC and the Detective's own investigation, a search warrant for a residence was obtained. As a result of this search warrant, numerous computers and other related electronic devices were recovered. One male subject was also arrested for 10 counts of Promoting Child Pornography and held in lieu of \$100,000 bail.

In October 2013, An ISB callout was initiated by PSB regarding a case about a nine month old infant being treated for injuries at the Wilcox ER. Wilcox ER reported treating the infant for injuries sustained in a fall while in the care of the babysitter. The medics responded to the residence and transported the infant to the Wilcox ER. The preliminary medical report stated that the infant has severe life threatening head injuries with bleeding in the brain and was subsequently flown via air ambulance to Queen's Medical Hospital in Oahu. Doctors both on Kauai and Oahu informed KPD that the injuries appeared to be suspicious.

In November 2013, a Detective conducted a burglary investigation pertaining to a residence located in the Lihue District belonging to a former district court judge. The residence was fully furnished but unoccupied by the owners for several years. Based on evidence located at the house it appeared that the suspect's not only stole items but were also living illegally in the residence. An adult male and also an adult female were identified and arrested for stealing items from the residence as well as sleeping in the residence without permission.

In the beginning of November 2013, Detectives investigated an in-custody death case at the Kauai Community Correctional Center. The deceased, a 55 year old male of Hanapepe, was found dead in his cell at KCCC. This investigation is still ongoing.

In November 2013, an 83 year old male from Kalaheo was arrested for Attempted Murder 1st Degree, following an attempt to locate and arrest the male subject on an unrelated arrest warrant. The male subject refused to exit the residence and fired a gunshot aimed towards the arresting police officers.

On November 27, 2013 it was discovered that a vehicle parked at Kee Beach helipad parking lot was broken into. The vehicle was left unattended while the renter was hiking. Various items were stolen from the vehicle including 4 credit cards. On November 28, 2013 the victim reported that various charges were made on his credit cards after they were stolen. The victim resides in Brazil and left Kauai on November 28, 2013. At the time of his departure a complete list of the illegal transactions were unavailable. Patrol requested the assistance of ISB Detectives in the case. A Detective was assigned to follow-up since he recently arrested a possible suspect. After sending several emails to the victim, he finally responded on December 16, 2013. The victim has been having difficulties returning to Brazil since his country documents were also stolen in the UEMV. Upon reviewing the information sent by the victim, it was learned that there were a total of 18 fraudulent transactions made on four credit cards for a total of \$8,124.46. Transactions were made at 11 different stores on the island from Princeville to Lihue. Knowing that

stores only hold video footage for a short period of time the Detective immediately began contacting the various stores and reviewing surveillance video where available.

Upon reviewing surveillance video at K-Mart, Wal-Mart, Safeway, Foodland and Longs the Detective was able to locate footage of 12 of the fraudulent transactions. The Detective was able to identify the suspect in 8 of the transactions and another suspect in 3 of the transactions. Based on the K-Mart and Wal-Mart surveillance video the Detective learned that the suspects were working as a team while making the transactions at those locations. Subpoenas have been issued to the stores that require a subpoena prior to turning over the surveillance video to KPD.

On January 1, 2014, Detectives investigated the death of an 88 year old male who was found dead in his home on New Year's morning. Investigation revealed that the deceased died from a single gunshot wound to the head. A subsequent autopsy conducted confirmed that the manner of death was a homicide. As a result of this death investigation, a 42 year old male was identified, arrested and charged with the murder of the 88 year old victim. The suspect is currently being held at the Kauai Community Correctional Center without bail.

During the last week of January 2014, Detectives investigated a report of a bank robbery and then later located a 36 year old male from Kapaa then subsequently arresting him for Robbery 2nd Degree. The suspect walked into the Kapaa Branch of Bank of Hawaii and approached a bank teller then demanded the teller to give him all of the money that the teller had. The suspect was held on bail at the Kauai Community Correctional Center and was eventually brought to court for a trial where he plead guilty to the bank robbery.

On April 4th, 2014, Officers responded to a discovery of a pipe-bomb next to Kalena Park in Lihue. The army EOD team arrived on island to dispose of the device. ATF agents arrived on island to assist with the investigation. Two adult male suspects were identified. This investigation is ongoing.

During the month of June 2014, a rash of burglaries, particularly in downtown Lihue including the Lihue Plantation Building on Kele Street in which half of its 30 tenants were burglarized. An extra effort by both the Patrol Services Bureau and Investigative Services Bureau was focused on attempting to apprehend the perpetrators(s). As a result of the combined efforts by both Bureaus, a 23 year old male from Lihue was arrested and charged for numerous offenses, including Burglary in the second degree, theft, and fraudulent use of a credit card. The suspect was held on \$175,000 bail pending trial.

COMMUNITY ORIENTED POLICING

During the month of October 2013, a Detective conducted a one hour presentation during the "Na Keiki Aloha O Na Ohana Conference held at the Kauai Beach Resort. During this presentation, the Detective focused on informing attendees about elderly abuse pertaining to internet scams, cyber bullying and phone scams. Attendees were very appreciative of

this informative presentation and had a better understanding of how to better be aware and help protect and report elderly abuse.

During the month of September 2013, Detectives conducted a one hour presentation at Chiefess Kamakahahei School pertaining to internet safety, online predators, sexting, and cyber bullying. There were approximately 53 people in attendance which comprised of parents and faculty of the school. There was also a question and answer session and some informational flyers were also passed out as a guideline pertaining to internet safety. Positive comments and feedback were received from many of the attendees.

During the month of October 2013, a Detective conducted a one hour presentation about stolen credit card users and counterfeit money clues, and tips to various merchants and office staff of the Kukui Grove Shopping Center.

During the month of November 2013, a Detective conducted a one hour presentation at the Kapaa Middle School covering internet safety, online predators, sexting, and cyber bullying. This presentation was provided to teachers and other faculty members of the Department of Education. There was also a question and answer session and some information flyers were passed out as a guideline pertaining to internet safety. Positive comments and feedback were received from many of the attendees.

In the month of November 2013, ISB Detectives conducted an information gathering, educational and follow-up investigation with witnesses and victims of the Kalaheo and Lawai areas. These areas were heavily targeted with a high number of burglaries and thefts. Detectives encouraged residents to report and call police quickly when suspicious activity or persons were in their neighborhood and to make sure that they properly secure and lock their vehicles and houses when they are not at home. The detectives also informed attendees on the type of detailed description to obtain of the suspicious persons and vehicles, and to include the time of day, type of clothing, age, ethnicity and other character traits such as tattoos and hairstyles.

TRAINING PROVIDED

Per a request from Kauai Government Employees Federal Credit Union (KGEFCU) management, Detectives provided an hour and a half bank robbery awareness training that consisted of a mock scenario of their bank being robbed by an armed suspect. This training scenario provided employees and management staff on tips of what to do and what not to do should a bank robbery occur at their establishment.

IN-SERVICE TRAINING PROVIDED TO PATROL

From July 1, 2013 to June 30, 2014, Detectives provided 4 in-service trainings to patrol officers and supervisors in the Waimea, Koloa, Lihue, Kapaa and Hanalei District. These trainings covered a range of topics which included consent to search, search warrant

preparation, search and seizure, unattended death investigations, Felony Call-Out Matrix procedures, crime trends and white collar investigations.

Special Focus Unit Highlights:

The Special Focus Section is tasked with the suppression, prevention and investigation of an array of crimes. The Section serves as a supportive role to the other elements of the Investigative Services Bureau and continues to provide specialized services to the community. The Section maintains these services through normal fiscal channels and grant funding. The Section contains elements including; School Resource/Dare Officers, White Collar Crimes Investigator, Cyber Crime Investigator, Domestic Violence Intervention Coordinator, The Sex Assault Nurse Examiners (SANE) program and a Youth Services/Missing Persons coordinator.

The Unit's Domestic Violence Coordinator (DVIC) is responsible for the intake and review of all cases involving family abuse, restraining and protective order violations, and domestic disputes. The DVIC refers the cases to the prosecutor's office for review, performs follow-up action, compiles data and ensures the victim's needs are met. The DVIC represents the Kauai Police Department on both the Domestic Violence and Suicide Prevention Task Forces and provides training both in-house and to the community at large.

The Sex Assault Nurse Examiners (SANE) program consists of trained and certified nurses who conduct the forensic examination during a sexual assault investigation. The SANEs will photograph, evidence collection and document their examination for the assigned detective. The SANE may be called upon to provide testimony during a court hearing or procedure related to the examination. The coordinator for the SANE program is Ms. Jennifer Antony.

The Youth Services/Missing Persons Coordinator position assists in all missing person investigations and conducts follow-up actions involving juvenile crimes and provides juvenile counseling services for first time offenders and coordinates referrals to "Teen Court."

The School Resource Officer unit is headed by a Sergeant. The three officers assigned to the unit received specialized training in dealing with juvenile related issues, and also conduct juvenile education, juvenile counseling and juvenile law related issues. The unit is tasked with the suppression, prevention and investigation of crimes committed by or against juveniles in the schools,

Law related Educational Presentations and Counseling and Mediation Services within their respective schools and throughout the community. The school-based program provides DARE/Keepin' it real, which is an Evidence Based Drug/Crime Prevention Education Program to all 7th graders in 3 public schools and 1 private middle school on the Island of Kauai. The unit handled all High School and many Middle School complaints, investigating 725 incidents which led to 638 arrests.

The Officers continue to be an extremely valuable asset in the schools, and their presence relieves the number of calls to the patrol services section. Further, the SRO Unit conducted grant-funded projects to combat under-age drinking and sales of alcoholic beverages and tobacco products to minors. School Resource Officers (SRO's) issued nine (9) citations to retailers for Tobacco Sale Violations, nineteen (19) citations to retailers and establishments for selling/serving alcohol to minors and arrested eight (8) juveniles for possession of alcoholic beverages during Park Sweep Details. These efforts have been successful as shown by the number of arrests and citations related to these types of violations.

Another operational focus of the section is the K-PAL program which serviced approximately 1500 juveniles between the ages of kindergarten to seniors in High School. K-PAL was formed to prevent juvenile crime, violence, and drug use, utilizing an after school and weekend recreation-oriented juvenile crime/drug prevention program that relies heavily upon athletics, recreational activities, evidence based education and police officers mentoring juveniles to help kids go right and stay right. Through our crime and drug prevention programs our mission and commitment is to "Filling Playgrounds, Not Prisons".

Program Highlights – Administrative and Technical Bureau (ATB):

The Research & Development Section:

The Research and Development Section is assigned to conduct background investigations on applicants for employment, procure uniforms and equipment, assist with department inventory, and has been instrumental in the hiring process.

The section is also responsible for initiating and formulating contracts, coordinating physical examinations and urinalysis screening, establishing safety and health programs, obtaining funding through various grants, and participating in various community related service projects. In addition, the section also conducts project research, analyzes crime trends, and coordinates the department's written directive system. The most critical role of the section continued to be the recruitment, hiring, and background investigations for both sworn and civilian employees. During FY 2014, several employees were hired: (9) nine Police Service Officers, (3) three Radio Dispatchers, (2) two School Crossing Guards, one Personnel Clerk, one Police Records Clerk, one Police Records Unit Supervisor, one Police Maintenance Equipment Coordinator and one Account Clerk.

The Research and Development section continues to explore ways to streamline and enhance the recruitment/hiring process, as we continue our goal of attracting and retaining the most qualified and best-suited applicants for the department.

The Community Relations Sergeant handles various tasks including station tours, oversees the department's chaplaincy program, job fairs, and career days at local schools. The Sergeant

also gives Neighborhood Watch Program presentations and other community related initiatives.

Citizen's Police Academy:

On June 17, 2014, 15 civilians graduated from the Kaua'i Police Department's 3rd Citizen's Police Academy. This graduating class, which began on April 15th, was a very diverse group. Some of the backgrounds of the class members included Police Chaplains, attorneys, farmers, county employees, a newspaper reporter, and a pharmacist just to name a few. During the academy the participants attended 13 sessions of police related classes which allowed them some insight as to what police officers are required to do. Citizens expressed their concerns, asked meaningful questions, and gained a better understanding of some of the decisions made by public safety professionals.

The Citizens Police Academy curriculum included an overview of recruit training, use of force, drill and ceremony, crime scene investigations, and simulated court. Attendees also got trained in emergency vehicle operations, became familiar with a firearm, and participated in a police ride-along.

In addition to learning about the various aspects of police work, participants in the class gained an understanding of the importance of police and community partnerships on Kaua'i. Participants came away from the class more aware of the challenges on our island, while also gaining a better understanding of the men and women who serve and protect it.

Training Section:

The Training Section continued to progress in improving services and programs to address areas of increased liability risk for the Kauai Police Department. The section also sought to provide quality training programs for personnel in an effort to keep up with the continuously advancing technological field of criminal investigations. For FY 2014, a department wide Annual Recall Training was implemented for the first time. The curriculum included range qualifications, reality based training, a physical fitness test, and pressure point and control tactics. The Training Section was tasked with scheduling both trainees and trainers for this event. The entire Department benefited from the most up to date and pertinent training.

More than 15,800 hours of training involving over 100 different training sessions were provided to police personnel throughout FY 2014. Some of the specialized courses included:

The online form was developed to make it easier for the community to anonymously report suspicious activities. GRANT PROJECTS FY2014

The Project Manager in each program is responsible for acquiring State and Federal grant revenue funds. Most grants extend over multiple years. The Administrative Bureau is accountable for the fiscal reporting and tracking of these grants.

1. State Highways Special Enforcement (State DOT - \$337,219):
Law enforcement and public education relating to distracted driving; deter drivers from drinking and driving, enforce underage drinking, enforce seatbelt and speeding laws and provide training for Traffic Safety Unit officers.
2. 911 Emergency Medical Services (State Department of Health - \$117,456, 3.0 E/P):
To operate a central 911 and dispatch communications center for emergency medical ambulance service.
3. Statewide Marijuana Eradication Task Force (State Attorney General - \$154,364):
To eradicate marijuana in Hawaii through a multi-agency/multi-jurisdictional cooperative effort.
4. Hawaii Narcotics Task Force (State Attorney General - \$142,421):
To prohibit drugs in the State by counteracting smuggling of narcotics via apprehension and conviction.

5. Domestic Cannabis Eradication/Suppression Program (U.S. Department of Justice- \$75,000):
To eradicate illegal cultivation of marijuana.
6. High Intensity Drug Trafficking Area HI-IMPACT (Office of National Drug Control Policy - \$62,930):
To combat the drug problem, specifically that of Crystal Methamphetamine.
7. State Law Prohibiting Tobacco Sales to Minors (Department of Health - \$17,125):
To reduce tobacco sales to minors.
8. State Law Prohibiting Alcohol Sales to Minors (Department of Health - \$17,000):
To reduce alcohol sales to minors.
9. SANE Recruitment, Training & Standby (State Attorney General - \$48,052):
To strengthen County of Kauai response to adolescent and adult female victims of sexual assault by recruiting, training and retaining new SANEs (Sexual Assault Nurse Examiners), and by providing continuing educations to current SANEs and sex crimes investigators.
10. SANE Exams and DNA Analysis (State Attorney General - \$63,903):
To provide SANE (Sexual Assault Nurse Examiners) exams to all adolescent and adult female victims of sexual assault according to the statewide examination criteria developed and adopted by members of HSART (Hawaii Sexual Assault Response Team), and to analyze forensic evidence to assist in the investigation.
11. Mental Health Transformation (Department of Health - \$20,000):
To support Kauai Police Department's efforts to divert appropriate, non-violent Individuals with mental illness from the criminal and juvenile justice systems.

Enhanced 911 Fund

Program Description:

The Enhanced 911 Fund was established in accordance with Act 159/SLH 2004, as a special fund outside of the state treasury, to be administered by the Enhanced 911 Board. The fund consists of monthly surcharge collections imposed on each Commercial Mobile Radio Service (CMRS) connection (wireless telephones and similar devices). The Administrative & Technical Bureau's Assistant Chief represents the County of Kaua'i at the State of Hawai'i Enhanced-911 Board meeting and Technical and Finance Committee meetings each month. The A&T Bureau is also responsible for the submittal of

reimbursement requests to the Enhanced 911 Board for corresponding expenditures detailed below.

1. Pictometry Intelligent Images - \$204,825:
Pictometry imagery and software enables users to “See Everywhere, Measure Anything, Plan Everything,” using a digital information system.
2. Akimeka, LLC. – \$219,873:
Provides continued Wireless Enhanced 9-1-1 (E9-1-1) Program Management and Geographic Information System (GIS) Services for Neighbor Island Counties to support on-going operations and maintenance of their E9-1-1 system
3. Hawaiian Telcom - \$111,398
HawTel Intrastate Tariff Charges charged for each Cache Meta Language (CML) position housed in a Public Safety Answering Point (PSAP). Tariff is necessary in order to receive emergency 911 calls. The Hawai‘i Telcom trunk charges are the only mechanism for the PSAPs to receive emergency 911 calls. Without this service, none of the emergency responders would be able to respond to emergency 911 calls.
4. VisionAIR, Inc. - \$3,800,000:
Contractor that will be installing and implementing Computer Aided Dispatch (CAD), Mobile Computer Aided Dispatch, Geographic Information System, Automatic Vehicle Location, Emergency Calling Data Center and Records Management System (RMS) upgrade.
5. Travel - \$6,840:
As a County representative, Acting Assistant Chief’s travel to the monthly Board meetings and monthly Finance and Technical Committee meetings are fully reimbursed by State funds for the Enhanced 911 Board.

VII. HOLO 2020 PROJECTS & STATUS

1. Accreditation

KPD applied for the accreditation process with CALEA and effective April 18, 2012, the application was accepted.

The Kauai Police Department will continue to review all current Standard Operating Procedures (SOP's) and General Orders (GO's). In addition, SOP's and GO's are being re-written or created in order to meet the directives set by The Commission on Accreditation for Law Enforcement Agencies (CALEA).

2. Support Crime Task Force

On November 12, 2013, The Community Relations Sergeant gave a presentation to the Mayor's Crime Task Force. The presentation covered fraud that targets senior citizens.

3. Complete Facilities Enhancement (Substations)

In an effort to provide suitable facilities for their personnel, the Kaua'i Police Department have made great strides in FY 2014.

Kawaihau District officers have temporarily relocated to the Kapaa Armory from the Kapaa mini-substation located next to the Kapaa soccer field. This move was long overdue and now allows the officers and community more space to interact.

4. Reduce Vacancies

Nine new Police Service Officers were hired and are expected to graduate from Academy training in December 2014.

5. Keeping Kaua'i Safe

Patrol Services Bureau (PSB):

Patrol Services Bureau conducted special projects throughout FY 2014 in an effort to help reduce crime on Kaua'i. Unfortunately the number of traffic fatalities remained consistent with a total of (6) six in FY 2014 as in previous years. Patrol officers issued a total of

21,385 traffic citations in the FY 2014 where 18,085 traffic citations were issued in FY 2013.
