- I am a representative of the applicant that is authorized to sign this Revocable Film Permit Application and make operational and financial decisions on behalf of the applicant;
- that the information contained in the this Revocable Film Permit Application and any attachments is true and correct to the best of my knowledge and belief;
- I have read, understand, and agree to abide by the rules and regulations governing the proposed production under the County of Kauai County Code and other applicable state and federal codes, laws, policies and regulations;
- I understand that the County cannot grant access to State or private land and that the applicant must apply directly with those landowners;
- the applicant will secure all necessary local, state, and federal permits, authorizations, and other approvals to use the property, equipment, or other components associated with the production, prior to beginning production;
- I understand in the event of a major incident, my production may be postponed or terminated for the sake of public safety and welfare (e.g., major crime incident, fire, flood, or acts of God).
- That the applicant will defend, indemnify, and hold harmless the County of Kaua`i, its officers, agents, assigns and employees from and against any and all claims for property damage, personal injury, or any other civil cause of action relating directly or indirectly to the applicant’s activities, including but not limited to claims for wrongful death that may arise from any activity engaged in by the applicant and or its officers, agents, assigns, and employees in undertaking the above mentioned project.
- That the applicant will obtain and maintain continuously in force for the duration of this permit, and any extension thereof, a liability insurance policy or policies as required in the Film Permit Guidelines.
- That the applicant will comply with special County of Kauai lighting requirements for night shooting as required in the Film Permit Guidelines.
- That the applicant will restore the County’s location(s), after use, to a condition which at least equals the location’s condition prior to use by the applicant and remove all signage, set dressing, sets and other fixtures, and refuse from the site, unless otherwise agreed to by the County of Kauai.

Permission is hereby granted by the County of Kaua`i to the Production Company/Applicant to utilize County of Kaua`i real property listed on the permit herein.

The Director of Finance finds that:

- The intended use does not conflict with use for immediate public purposes; and
- There is no reasonable alternative other than the use of public property; and
- The proposed use does not create a nuisance or unreasonably affect public health or welfare; and
- There is no conflicting request for use of the particular public property; and
- The revocable permit shall be limited to a month-to-Month basis or less. The County may revoke this Film Permit by giving Producer fifteen (15) days written notice stating the reason for revocation.
- The fair market rental value shall be a credit in the end titles of the film specifying Kaua`i as a location where filming of the production took place, recognizing the assistance of the Kaua`i Film Commission.
