Project components include improvements on Rice Street, Hoala Street, Kalena Street, Hooloko Street, Puaole Street (between Malae Street and Hooloko Street), Malae Street (between Hardy Street and Puaole Street), and a shared use path from the Civic Center to War Memorial Convention Hall. The purpose of the project is to improve connectivity and safety for motorists, bicyclists, pedestrians, and transit users within the project area. This proposed project is a federally funded County project. As such, it will be considered a federal action and undertaking, as defined by Section 106 of the National Historic Preservation Act (NHPA) of 1966, as amended (2006). Construction anticipated to begin in 2018.
