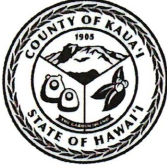
Public Comments and Testimony:

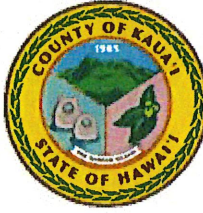
