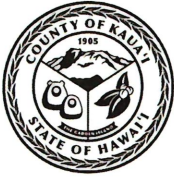
- Meetings will be publicly noticed pursuant to HRS Chapter 92.

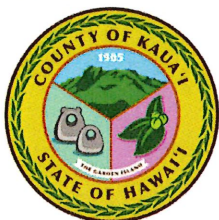
