	It was noted for the record that the update on the Chief's FY 2021-2022 goals have been completed and Staff acknowledge it and will make the necessary changes to the next month's agenda.	
	In addition to the data reflected in his Monthly Bureau Reports, Fire Chief Gibson gave an overview of the highlights and changes since the last Fire Commission meeting. He noted that if the Commissioners have any questions regarding his reports and updates, he would be more than happy to stop to answer their questions.	
	 Fire and Ocean Safety Highlights: The 32nd Fire Fight Recruit Class is in week 14. The recruits are currently in the EMT held at the Kauai Community College and is 8 weeks long. This is the final week for the Kauai Junior Lifeguard Program. The Kauai Lifeguard Association is the main sponsor and will be covering the cost for the Kauai Keiki's to travel to O'ahu to compete in the 2023 State Junior Lifeguard Championship. KFD firefights helped with the setting up the tents for the 2023 Kauai Hospice Concert in the Sky at the Vidinha Stadium in Līhu'e. The Kauai Fire Department/Ocean Safety participated in the 2nd Annual Touch-A-Truck Event hosted by the Kauai Police Department. Next event is the Kōloa Planation Days Event. Ladder 4 will be participating in the parade on July 29, 2023, and the team from OSC will be joining them in the festivities which will be held at the Kōloa Park following the parade. 	
	 Partnerships: Earlier in the month of July both Fire Chief Gibson and Deputy Fire Chief Mills flew to O'ahu to meet the Hawai'i Fire Fighters Association union leadership. Other Fire Chiefs and their Deputies from the other counties flew in as well. The event lasted for two days and was very educational for both sides.

	 Fire Chief Gibson and members of his team met with a concerned citizen with a medical condition to address fireworks occurring in her neighborhood of Wailua House lots, and how it is negatively affecting her wellbeing. In a joint effort Fire Chief Gibson, Councilmember Felicia Cowden walked the neighborhood as a deterrent to the keep citizens from using fireworks. Councilmember Ross Kagawa was contacted by a concerned citizen in Hanapēpē about a large oversize lot where people have built sheds for them to live in. Although it is not illegal it is still an eye sore one of the sheds caught on fire. A group consisting of the building, police and fire will be working together to come up with a solution. Councilmember Billy Decosta reached out to the state to get funding for needed repairs to the historic Obake Bridge in Hanapēpē. When asked by Councilmember Decosta on how important the bridge is for police and fire, Chief Gibson replied the bridge is a critical for fire and police in case of unexpected emergencies. The work on Hanalei Bridge is completed. Resources: KFD's 6 long-term vacancies on the fire side the of those are long-term on-duty injuries and the other three are off-duty injuries. OSC three current vacancies include one captain (KFD is working fill the position), one lieutenant position due to retirement, and one long-term ocean safety position due to long-term injury. 	 Fire Prevention Bureau: The bureau conducted investigates on a couple of small structural fires last year but could find the cause. The bureau will be sending the three investigators to O'ahu for training next month. 	
	 Fire Training Bureau: Aside of the 32nd Recruit Class training, the bureau is gearing up for next month's USLA (United States Lifeguard Association)Training. PADO (Pumping Apparatus Driver Operator) Class for RC31 had to rescheduled due to manpower issues. The class is scheduled for August 7-11, 2023. The Peer Support Behavior and Health/Awareness Training is completed. 16 firefighters participated in the training.

	Vice Chair Yama commented that relative to the elderly woman who lives in Wailua	
	house lots open burns may have an effect on her as well. Another example that may	
	affect her are people smoking meat, having barbeques, or cooking outdoors.	
	Chair Chahanovich asked when walking in the neighborhood if the residents were open	
	to trying to understand the issue at hand to which Fire Chief Gibson replied that some	
	residents did express appreciation for them walking in the neighborhood.
