

AMENDMENT NO. 1 TO CONTRACT NO. 8727

THIS AMENDMENT NO. 1 TO CONTRACT No. 8727, dated August 1, 2012, is executed by and between the COUNTY OF KAUA'I, a political subdivision of the State of Hawai'i, whose place of business is 4444 Rice Street, Suite 235, Lihu'e, Hawai'i 96766 ("County") and Smith Dawson & Andrews, Inc., a District of Columbia corporation, 1150 Connecticut Avenue, Suite 1025, Washington, D.C. 20036 ("Consultant").

WITNESSETH:

WHEREAS, County and Consultant entered into a Consultant Agreement, Contract No. 8727, ("Contract") which terminates on September 30, 2012 unless extended by the parties for a period not to exceed nine months;

WHEREAS, County and Consultant desire to extend the term of the Contract for a period of nine months;

WHEREAS, the Director of Finance approved an amendment to the exempt procurement for the Contract on July 26, 2012;

AGREEMENT:

NOW THEREFORE, in consideration of the above recitals, of the mutual promises of County and Consultant, and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, County and Consultant agree as follows:


Section No. 3 of the Contract is amended to extend the termination date of the Contract from September 30, 2012 until June 30, 2013.



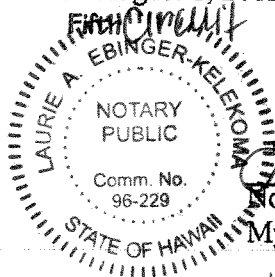
