C 2025-200 Communication (08/29/2025) from the Prosecuting Attorney, requesting Council approval to receive and expend Opioid Settlement funds in the amount of \$100,000.00, from the State of Hawai'i, Department of Health, Alcohol and Drug Abuse Division (ADAD), County Coordination for Substance Abuse Prevention System, formerly known as the Strategic Prevention Framework – Partnership for Success grant, which will support personnel costs of the Prevention Services Specialist, coordinate prevention programs, coalitions, and activities within the County of Kaua'i, and help staff to participate in training courses and conferences. C 2025-201 Communication (09/10/2025) from the Prosecuting Attorney, requesting Council approval to receive and expend Federal Fiscal Year 2026 funds, in the amount of \$133,892.90, from the Impaired Driving Grant, and to indemnify the State of Hawai'i, Department of the Attorney General, to reimburse up to 1,040 hours of the Traffic Safety Prosecutor's position as well as travel costs for training and meetings.
