Re: Clarification of Lobbyist Contributions and Expenditures Statement; Nancy Ann Kanna; January 18, 2017

Dear Ms. Fountain-Tanigawa,

The purpose of this letter is to clarify my lobbying activities on behalf of the Kauai Board of Realtors (KBR) and monies received on behalf of those services. A statement submitted (on my behalf) by Karen Ono of the Kauai Board of Realtors does not correctly state the areas of lobbying and expenditures for lobbying services (reference Lobbyist Contributions and Expenditures Statement signed 1/9/2017 and received by the Kauai Office of the County Clerk on 1/10/2017).

Lobbying accounted for a small portion of the contracted duties performed for KBR. Ms. Ono, as the Executive Director of KBR, states the *entire* amount of monies received for *ALL* contracted duties performed from November 1, 2015 to August 15, 2016. This is incorrect. Given the lobbyist law going into effect on August 1, 2016, and the contractual nature and structure of billing KBR, I do not have detailed records of every "lobbyist activity." I can, however, estimate the time spent on such activities and assign a monetary amount accordingly.

As stated on the attached Statement, I provided lobbying services for the lobbyist bill, ARU bill, multiple family dwellings bill, TIGER Grant Resolution, the Lima Ola Housing Project, and the FRC increase. I have liberally estimated the amount of time allotted to lobbying on these subject areas, (from January 1, 2016 through August 15, 2016) to be approximately 8% of my time or \$2,000.
