Bill No. 2835

A BILL FOR AN ORDINANCE AMENDING ORDINANCE NO. B-2021-877, AS AMENDED, RELATING TO THE OPERATING BUDGET OF THE COUNTY OF KAUA'I, STATE OF HAWAII, FOR THE FISCAL YEAR JULY 1, 2021 THROUGH JUNE 30, 2022, BY REVISING THE AMOUNTS ESTIMATED IN THE GENERAL FUND (*Special Election - Prosecuting Attorney - \$475,000.00*)

This Bill proposes to amend Ordinance No. B-2021-877, as amended, relating to the Operating Budget of the County of Kaua'i, State of Hawaii, for the Fiscal Year July 1, 2021 through June 30, 2022, by utilizing \$475,000.00 from the Equity / Fund Balance – Unassigned account to fund the costs associated with the Special Election for the office of Prosecuting Attorney to be conducted by the Office of the County Clerk, Elections Division, due to the retirement of the Prosecuting Attorney effective September 30, 2021.

All interested persons who wish to present their comments may do so at the public hearing. Written testimony prior to the hearing would be appreciated. Written testimony can be submitted to the Office of the County Clerk, Council Services Division by mail, facsimile, or via E-mail to counciltestimony@kauai.gov. Copies of the Bill are available at the Office of the County Clerk, Council Services Division.


