Tax Fund, Solid Waste Fund, Sewer Fund, and Golf Fund. This Bill appropriates \$6,200,276.00 to fund the Settlement Agreement with the United Public Workers (UPW), Bargaining Unit 01 (BU-01) employees for the purpose on Temporary Hazard Pay (THP) for exposure to the Coronavirus Disease 2019 for BU-01 members employed during the period of March 4, 2020 to March 5, 2022, including portions thereof, and to resolve the various THP class grievances submitted by UPW.
