Bill No. 2841

A BILL FOR AN ORDINANCE AMENDING ORDINANCE NO. B-2021-877, AS AMENDED, RELATING TO THE OPERATING BUDGET OF THE COUNTY OF KAUA'I, STATE OF HAWAII, FOR THE FISCAL YEAR JULY 1, 2021 THROUGH JUNE 30, 2022, BY REVISING THE AMOUNTS ESTIMATED IN THE GENERAL FUND (*Liability Insurance Premiums - \$315,000.00*)

This Bill proposes to transfer \$315,000.00 from the General Fund Equity/Fund Balance – Unassigned account to the Department of Finance – Administration Liability Insurance account to cover the County's insurance premiums which have exceeded prior estimates.

All interested persons who wish to present their comments may do so at the public hearing. Written testimony prior to the hearing would be appreciated.
