# Resolution

**RESOLUTION ESTABLISHING THE REAL PROPERTY TAX RATES  
FOR THE FISCAL YEAR JULY 1, 2023 TO JUNE 30, 2024  
FOR THE COUNTY OF KAUA'I**

WHEREAS, pursuant to Section 5A-6.3, Kaua'i County Code 1987, as amended, the Council of the County of Kaua'i desires to fix and establish the real property tax rates for the tax year July 1, 2023 to June 30, 2024, by June 20, 2023; and

WHEREAS, the Department of Finance has certified that the net value of taxable real property in the County for the tax year 2023-2024 is \$30,780,394,100; and

WHEREAS, via the certification from the Director of Finance dated March 6, 2023 and transmitted to the Council on March 15, 2023, and the Supplemental Property Tax Revenue Information from the Director of Finance dated March 15, 2023, the Council was informed of an estimated loss in tax revenues of: \$305,096 due to the Very Low-Income Tax Credit, and \$16,354 due to the Home Preservation Limit Differential; now, therefore,

BE IT RESOLVED BY THE COUNCIL OF THE COUNTY OF KAUA'I, STATE OF HAWAII, that the Council does hereby fix and establish the real property tax rates for the several classes of real property for the Fiscal Year July 1, 2023 to June 30, 2024, as computed in Exhibit I attached hereto:


