New Business (For Action)	<p><u>I.1.</u> Update on a 1.8-acre property known as Kaluanono, further identified as Tax Map Key (TMK) (4) 5-6-004:010 and a .25 acre property known as Halulu Fishpond further identified as Tax Map Key (TMK) (4) 5-6-004:007 located in Waipā, Waipā Ahupuaa, Halale‘a Moku. (Preliminary report 4/19/15, Supplement report 5/9/19)</p> <p>Ms. Higuchi Sayegusa shared the following;</p> <ul style="list-style-type: none"> • Project came before this commission several times in the past. In 2019 the commission recommended \$850,000 to acquire Kaluaono and Halulu Fishpond. • Amended the proposal to acquire only the Halulu Fishpond for \$850,000. <p>Ms. Higuchi Sayegusa announced there was no one from the public in person to testify on this agenda item and Planner Shelea Koga stated there was no one from the public on Zoom.</p> <p>Waipā Foundation Executive Director Stacy Sproat and Hawaiian Island State Director at the Trust for Public Land Lea Hong shared a 22-page power point presentation titled Halulu Fishpond Access Waipā, Halele‘a, Kaua‘i ;</p> <ul style="list-style-type: none"> • Waipā Foundation was a for-profit that had an agriculture lease of 1600 acres from Kamehameha Schools since the mid 1980’s. There were 19 kuleana parcels embedded in the Waipā ahupua‘a. Waipā provides a variety of cultural events from keiki to kupuna. • Big issue was Halulu Fishpond buffered along the edge of a property that could be

	<p>developed and change the view and ambiance of the surrounding area.</p> <ul style="list-style-type: none"> • In 2019 the commission recommended \$850,000 to acquire Kaluanono and Halulu Fishpond access parcels. The Waipā Foundation has since changed its use of Kaluaono but will work with Waioli Corporation on acquiring the Kaluaono property to prevent future development. • Now in 2022 they were requesting \$850,000 to acquire the Halulu Fishpond access property. The access trail was a crucial part of entering the fishpond area. • Ms. Hong, State Legacy Land Conservation Program shared that they have secured the following funds; <ul style="list-style-type: none"> ○ State Legacy Land Conservation Program secured \$50,000 ○ Senator Ron Kouchi earmarked \$400,000 of state CIP (Capital Improvement Project) that will expire June 30, 2023 ○ Requesting Kaua‘i County Public Access, Open Space and Natural Resources Preservation fund \$850,000 ○ Total purchase price \$1.1 to \$1.3 million pending appraisal. • Have an agreement with Waioli Corporation to purchase between \$1.1M to \$1.3M • TPL appraisal was \$1.24M and a 2019 County appraisal came in at \$1.1M • Kaua‘i County would hold the conservation easement that would restrict development in perpetuity and Waipā would steward and manage the makai public access and cultural programs. <ol style="list-style-type: none"> 1. Mr. Ono inquired who owned the property on the opposite side of the pond. Ms. Sprout responded they lease 22 acres from Kamehameha Schools on the makai side. 2. Chair Pro Tem Kanna commented that they could not place a value on the programs that Waipa Foundation serves its community. She appreciated that they connect people to land, connect people to the ocean and would steward the land in perpetuity. 3. Ms. Dizon commented that it was heartwarming to see how their programs engaged the keiki and kupuna connecting them to each other. She asked how they would manage their property from coastal erosion. Ms. Sprout said the erosion was on the makai side and the pond buffered the erosion, most of the property was further back and probably

	<p>would not be affected. Ms. Sproat said Waipa Foundations lease was to 2050 and was confident that they could renew it, but they were still vulnerable. She said having a presence there would influence any future development of the area.</p> <p>4. Chair Pro Tem Kanna asked if the erosion was caused by sea level rise. Ms. Sproat replied that she wasn't sure if it was part of a cycle or sea level rise; but since then, the sand had refilled its way back to the beach.</p> <p>5. Chair Pro Tem Kanna asked how the foundation dealt with the neighbors. Ms. Sproat replied that they have been there longer, and the properties have undergone multiple changes in ownership. They have a mutually beneficial relationship with the current owners who have become allies, friendly, donate and support the foundation. They are conscientious to have events that do not encroach on their neighbor's privacy and keep noise to a minimum.</p> <p>6. Ms. Higuchi Sayegusa asked what the next steps were. Ms. Hong said the next steps would be to get an updated appraisal, draft the conservation easement and finish an environmental survey.</p> <p>7. Chair Pro Tem Kanna asked what would happen to the funds if the appraisal came in lower what would the plan be for the excess funds. Ms. Hong replied that they would use up to \$850,000 and any extra would be left in open space.</p> <p>8. Mr. Lucas commented that this acquisition made sense with all the other funding in place. He concurred with Ms. Dizon's comments and overall recommended the</p>	<p>Mr. Ono motioned to recommend approval of Public Access, Open Space and Natural Resources funds up to \$850,000 to acquire a .25 acre property known as Halulu Fishpond further identified as Tax Map Key (TMK) (4) 5-6-004:007 located in Waipā, Waipā Ahupuaa, Halale'a Moku, access and executing the easement.
