Public Works Program

The Public Works Program empowers distressed communities to revitalize, expand, and upgrade their physical infrastructure to attract new industry, encourage business expansion, diversify local economies, and generate or retain long-term, private sector jobs and investment. This program is administered by the Economic Development Administration.

Save America's Treasures

This award program assists the preservation and conservation of nationally significant historic sites and collections across the country. These grants are administered by the National Park Service (NPS) in partnership with the National Endowment for the Arts, the National Endowment for the Humanities, the Institute of Museum and Library Services and the President's Committee on the Arts and the Humanities. Grants require a dollar-for-dollar non-Federal match, which can be cash, donated services, or use of equipment.

The Historic Preservation Fund (HPF):

HPF grants serve as a catalyst and "seed money" for preserving and protecting our nation's irreplaceable heritage for this and future generations. Funding is used by States and local governments to pay part of the costs of the following activities: architectural, historical, archeological surveys; nominations to the National Register of Historic

Places; staff work for historic preservation commissions; design guidelines and preservation plans; public outreach materials such as publications, videos, exhibits, and brochures; training for commission members and staff; and rehabilitation or restoration of National Register-listed properties. Grants are administered by the National Park Service Heritage Preservation Services.

<u>Certified Local Government (CLG)</u>

Grant funds are distributed through the HPF grant program. Working closely with such national organizations as the National Association of Preservation Commissions, the CLG program seeks: 1) to develop and maintain local historic preservation programs that will influence the zoning and permitting decisions critical to preserving historic properties, and 2) to ensure the broadest possible participation of local governments in the national historic preservation program while maintaining preservation standards established by the Secretary of the Interior.

Hawaii Preservation Services Fund

The Historic Hawaii Foundation provides matching grants ranging from \$500 to \$5,000 to nonprofit organizations and public agencies to initiate preservation projects. Funds may be used to support consultants with professional expertise in areas such as architecture, law, planning, economics, and graphic design; conferences that address subjects of particular importance to historic preservation; and curriculum development in preservation directed toward select audiences.
