## 2025 LONG-TERM AFFORDABLE TENANT OCCUPIED RENTAL PROGRAM ANNUAL DEADLINE FILING SEPTEMBER 30th

**NOTICE:** (1) Changes to any existing Rental/Lease Agreements must have the initials of the tenants, owner or agents.
(2) The application must have the original signature of the Owner, <u>no agents' signatures</u>. (3) Those submitting Rental/Lease Agreements expiring October 31st or before, must provide the renewal agreement not later than November 15, 2024.

For applicants who file and are approved for the 2025 tax year, and provided multi-year lease with tenant name, term of lease, if tenant pays utilities described below, if multi dwellings on the property provide the unit number covered by lease and affordable rent amount clearly stated in the lease agreement, may consider this application and its approval good for up to three (3) years.
